GREENSTONE RESOURCES LIMITED - SHARE PURCHASE PLAN

Greenstone Resources Limited ACN 093 396 859 ("**Greenstone**" or the "**Company**"), is pleased to be making a prospectus offer of Share Purchase Plan (**SPP**) shares and Options to eligible shareholders (**SPP Offer**).

The SPP follows Greenstone's institutional placement announced on 24 July 2023 which raised \$1.7 million before costs by issuing placement shares at \$0.013 per share. The free attaching options are to be issued under the placement to the placees on the basis of one (1) free attaching option for every two (2) shares subscribed for (rounded down to the nearest whole option). The Placement Options will be exercisable at a price of \$0.025 per share with an expiry date two (2) years from the date of issue.

The SPP shares and options will be issued on the same terms as the placement securities. The SPP shares are offered at \$0.013 per share and the free attaching options on the basis of one (1) free attaching option for every two (2) SPP shares subscribed for, with the SPP Options exercisable at a price of \$0.025 per share with an expiry date two (2) years from the date of issue. Greenstone is seeking to raise \$250,000 (before costs) through the SPP Offer, with the ability to take up to an additional \$250,000 at the Company's discretion.

The SPP securities are being offered by the prospectus. Please read the prospectus and follow the instructions on the SPP Application Form.

Eligible shareholders may apply for SPP shares ranging from a minimum value of \$1,000 up to a maximum value of \$30,000.

The SPP Offer opens on Friday, 18 August 2023 and closes on Friday, 15 September 2023.

Details of how to obtain a copy of the Prospectus, together with your personalised application form appears on the following page. Shareholders with registered addresses outside of Australia and New Zealand are not eligible to participate in the Offer, as detailed in the Prospectus.

Greenstone will **not** be printing/dispatching hard copies of the Prospectus or Application Forms, except in response to specific requests by a Shareholder (please refer to table on following page).
