Contract awards

Southern Cross Electrical Engineering Limited (“SCEE Group”) is pleased to announce that its SCEE Electrical, Heyday and Trivantage businesses have received a range of awards across various sectors in Queensland, Western Australia, New South Wales, and the ACT totaling over \$90m as follows:

- SCEE Electrical has been awarded a range of security upgrade works at the Dysart and Moranbah accommodation villages in the Bowen Basin in Queensland for Civeo Pty Ltd. These design and construct projects include upgrades to access, lighting and security systems for the villages and will be drawing on capabilities from businesses across the SCEE Group, including electrical, security and communications services from each of SCEE Electrical, SEME Solutions and Datatel respectively. The contracts have commenced and are anticipated to be completed by April 2024.
- SCEE Electrical has also been awarded a similar project at the Stayover Dysart accommodation village in the same region for Ausco Modular Pty Ltd. These works will be performed in the same timescale as above.
- SCEE Electrical has been awarded an electrical and instrumentation package by CPB Contractors Pty Ltd who have secured the Mount Keith Debottlenecking Projects – SMPE&I Work Scope at BHP’s Mount Keith mining operations in WA. SCEE Electrical’s scope includes the deconstruction of existing cabling and devices to enable the mechanical works, and then installation of new High Voltage and Low Voltage instrument and control cabling and electrical and instrumentation equipment with a date for completion in April 2024.
- In WA at Rio Tinto Iron Ore’s Tom Price mine, SCEE Electrical has been selected by Hamersley Iron Pty Limited to deliver the Clarified Water Tank and Pump Station Project. SCEE Electrical will be installing the electrical and piping infrastructure for the new pump station which will replace the existing system currently in service. The works have commenced and are forecast to be completed in the fourth quarter of 2023.
- SCEE Electrical has been awarded a one-year extension to its Master Services Agreement (MSA) by CITIC Pacific Mining Management Pty Ltd to provide electrical maintenance services at the Sino Iron Project in WA. The award extends SCEE Electrical’s long-standing relationship with CITIC

Pacific Mining on that project. SCEE Electrical has been operating under an MSA at the Sino Iron Project since 2015.

- Multiplex Constructions Pty Ltd has added a further works package to Heyday's Western Sydney International (Nancy-Bird Walton) Airport project of which SCEE announced the award to the ASX on 1 November 2021. This further works package is part of the Australian Border Force's integrated fit out within the main terminal building. Heyday's scope is to provide electrical and communications services to enable Border Force's operations at the airport to commence once the airport is functioning, including baggage screening, passenger screening, interview rooms, passport processing areas and office space for operational staff. Works on this package will commence immediately and are expected to be completed by January 2025.
- In Canberra, Hindmarsh Construction Australia Pty Ltd has awarded Heyday the design and construct contract for electrical and communication services for the first stage of the Woden Green development, located in the Woden town centre. The development comprises 419 apartments across three multistorey towers and shared common spaces, including three basement carpark levels and gardens. The project has just commenced and is estimated to be completed in mid-2025.
- In NSW, Snowy Hydro Limited has awarded a contract to Trivantage Manufacturing for the manufacture and delivery of low voltage switchboards that will replace the existing switchboard assemblies at the Tumet 3 Power Station. The switchboards are expected to be delivered by May 2023 for installation by Snowy Hydro.

Comment

Commenting on the above, SCEE Group Managing Director Graeme Dunn said "The range of these projects shows the sectoral and geographic diversity of the SCEE Group as it has now become. Adding these to other recent awards means we have announced over \$200m of new works over the last few weeks and consequently we are entering the 2024 Financial Year with a record order book for the Group.

In particular, I am pleased we have now commenced work on a range of accommodation villages in Queensland having successfully completed a series of similar projects in the Pilbara over the last 18 months, and for which delivery the collaboration is required from multiple businesses across the group."
