# LIONTOWN SOIL GEOCHEMISTRY PROGRAM COMPLETED AT MULWARRIE LITHIUM PROJECT

## **Highlights**

- Liontown Resources (ASX:LTR) has completed the final stage of the soil geochemistry program across the Mulwarrie Lithium Project .
- A total of 1,135 soil geochemistry samples have been collected, as per the terms of the Farm-in Agreement.
- All samples have been submitted to the lab for analysis, with results for the full program anticipated in 4-5 weeks.

**Olympio Metals Limited (ASX:OLY)** is pleased to announce that Liontown Resources Limited (ASX:LTR) (**Liontown**) has completed the planned soil geochemistry program over the Mulwarrie JV tenements, which form part of the Mulwarrie Lithium Project, located in the Eastern Goldfields of Western Australia (Figure 2).




Figure 1: Mulwarrie and Mulline Prospects

The Mulwarrie and Mulline Prospects are considered to be prospective for lithium mineralisation, in the same geological setting as Delta Lithium Limited's (ASX:DLI) Mt Ida lithium deposit to the north<sup>1</sup> and Ora Banda Mining Limited's (ASX:OBM) recently announced significant Davyhurst lithium discovery<sup>2</sup> to the south (Figure 1).

With reference to the ASX announcement dated 3 April 2023, the soil geochemistry program has been completed as per the terms of the Farm-in Agreement. All samples have now been submitted for multi-element analysis, and results are expected in 4-5 weeks, subject to the lab turnaround time.

### Olympio's Managing Director, Sean Delaney, commented:

"Liontown have completed a comprehensive soil sampling program over the Mulline and Mulwarrie Prospects, which will provide a quality dataset to evaluate the lithium potential.

"The program took a little longer than anticipated due to heavy rainfall and some difficult terrain to be accessed but Liontown have done a great job sampling all the greenstone areas as agreed. We look forward to the results for the complete program, which should be available over the coming weeks."



#### **Soil Geochemistry Program**

Liontown collected 1,135 samples at the Mulline and Mulwarrie Prospects during the period of June-August 2023 (Figure 1). The samples have been submitted to ALS for multi element analysis.

The Mulwarrie and Mulline Prospects are considered to be prospective for LCT pegmatite mineralisation, with lithium mineralisation identified in the region. To the north, Delta Lithium<sup>1</sup> (formerly Red Dirt Metals) are developing the Mt Ida lithium deposit, whilst Ora Banda Mining<sup>2</sup> has announced results of up to 11m @ 1.28%  $\text{Li}_2\text{O}$  on neighbouring tenements (Figure 1).




Figure 2: Liontown soil sampling locations - Mulwarrie and Mulline Prospects
