HERITAGE SURVEY COMMENCEMENT CONFIRMED

SURVEY TO FOCUS ON SEVERAL PROSPECTS AT THE YANDAL AND EARAHEEDY PROJECTS

Key Points:

- **Heritage Survey scheduled to commence on October 9, 2023**
- **Areas of focus for clearance include Great Western, Rabbit Well, Cowza and several regional gold prospects within the Yandal project**

Introduction

Strickland Metals Limited (ASX:STK) (**Strickland** or the **Company**) is pleased to provide an update on its Heritage Survey commencement at the Company's Yandal and Earahedy projects.

Heritage Survey Scheduled

A Heritage Survey has been confirmed to commence at the Company's Yandal and Earahedy projects on October 9, 2023. The survey will seek clearance for areas around Strickland's promising Great Western, Rabbit Well and Cowza prospects.

Heritage clearance at Great Western will allow the Company to undertake follow up drilling (see ASX announcement 17 August) at what appears to be a very compelling, large and entirely untested gold prospect. An IP survey is currently underway with results expected within the fortnight.

Clearance will also allow drilling at the Cowza prospect, where the Company believes it has the potential to replicate its success at Millrose (see ASX announcement 4 August 2023).

Finally, the survey will also take in the Rabbit Well prospect, where historic drilling has detected elevated zinc anomalism in shallow holes coincident with a significant gravity feature (see ASX announcement 4 August 2023). Rabbit Well has the potential to be a much larger and more coherent target than our Iroquois base metal prospect.

Follow up diamond drilling is scheduled to commence immediately after clearance has been received in late October 2023.
