Highlights

- The 101 mineral property titles comprising the Ceiling Project have been fully transferred to Rubix Resources Limited’s Canadian-based subsidiary
- Kitara Investments Pty Ltd and DG Resources Management have become substantial shareholders of Rubix
- Field work is due to commence shortly following the complete removal of travel restrictions by both SOPFEU and MERN

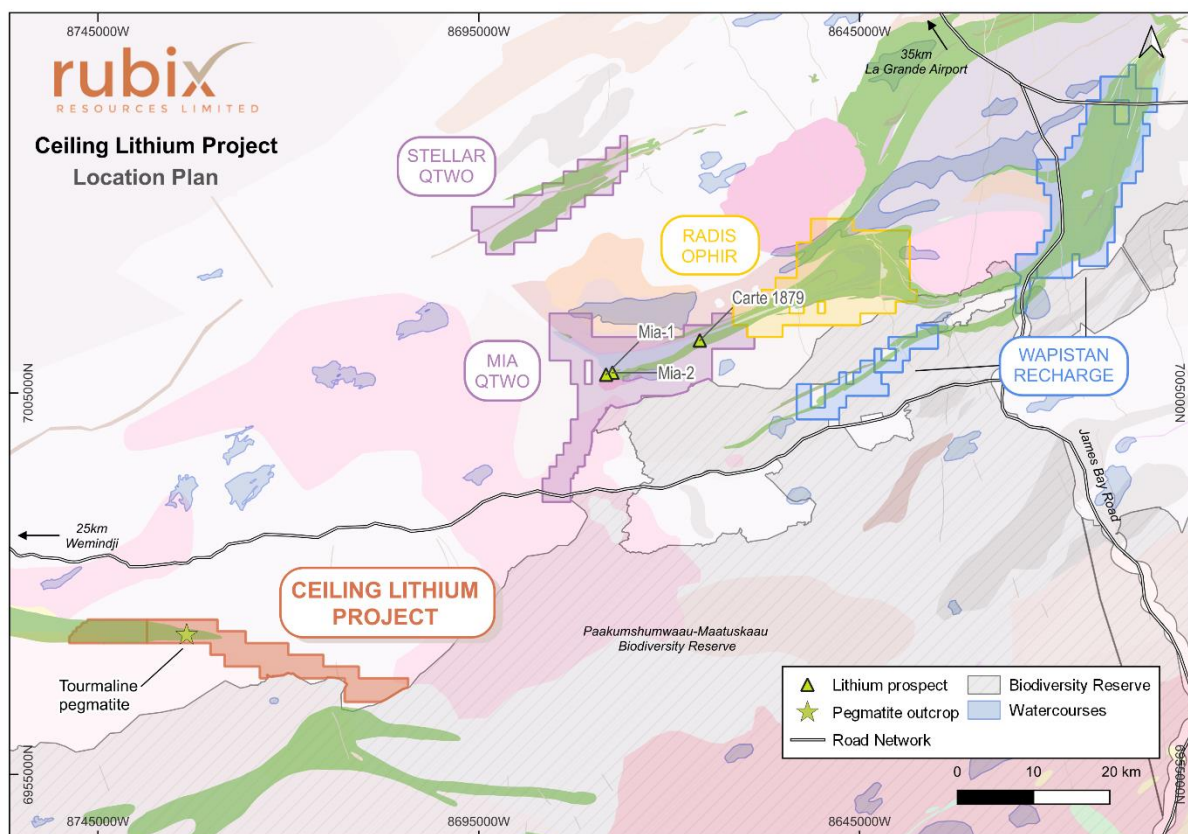


Figure 1 – Location of the Ceiling Lithium Project and neighbouring lithium projects, overlaid on regional geology

Rubix Resources Limited (ASX: RB6, “**Rubix**” or the “**Company**”) is pleased to announce the completion of its acquisition of 100% ownership of the Ceiling Lithium Project (“**Ceiling**” or the “**Project**”) in James Bay, Quebec.

Following the Quebec summer holiday period, the transfer of the mineral claims to Rubix Resources Canadian subsidiary company has now been completed by MERN. Rubix Resources' Canadian subsidiary (9486-224 Quebec Inc) now holds all 101 titles.

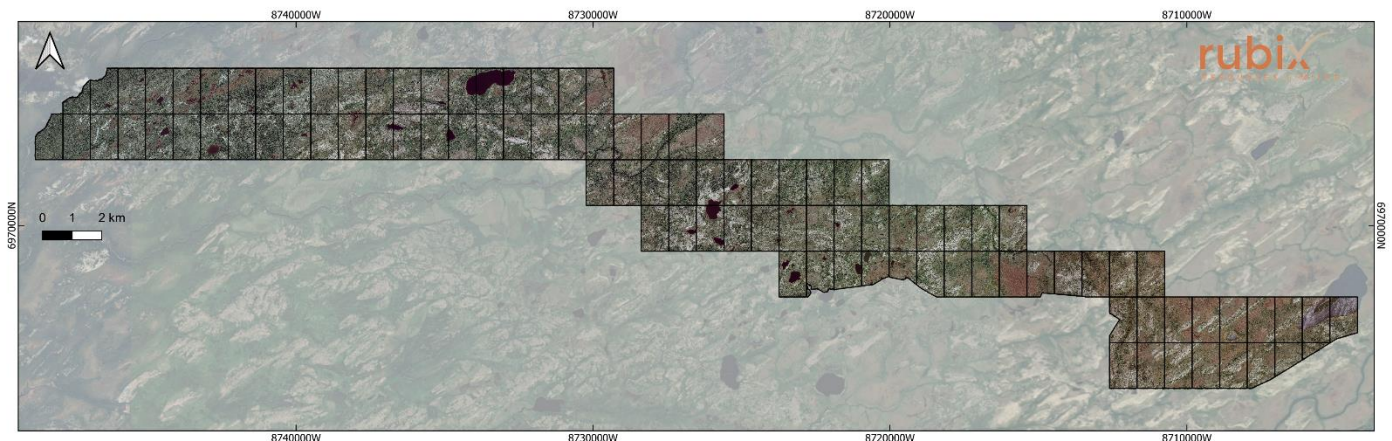


Figure 2 – The Ceiling Lithium Project mineral exploration properties

Material terms of acquisition

As per the binding agreement with Vendors on 24 May 2023, Rubix has completed the issuance of:

- A cash payment of AU\$200,000
- 12,500,000 Fully Paid Ordinary Shares
- 15,000,000 Listed Options to acquire fully paid ordinary shares in the capital of Rubix, exercisable at AU\$0.20, on or before 16 June 2025
- Issuance of 25,000,000 Performance Rights in two tranches:
 - 12,500,000 Tranche 1 Performance Rights will convert into shares subject to announcement of at least five rock chip or trench sampling assay results from the Ceiling Lithium Project of at least 1% Li₂O;
 - 12,500,000 Tranche 2 Performance Rights will convert into shares subject to delineation of an inferred JORC Resource (or higher resource classification) totalling at least 10 million tonnes at a minimum grade of 1% Li₂O;
 - Each performance right will expire on the date that is four years from the date of issue
- A 2% net smelter royalty on all minerals produced and sold from the Ceiling Lithium Project subject to the delineation of an economic resource.

At completion of the acquisition, Kitara Investments and DG Resources Management become substantial shareholders of Rubix Resources.

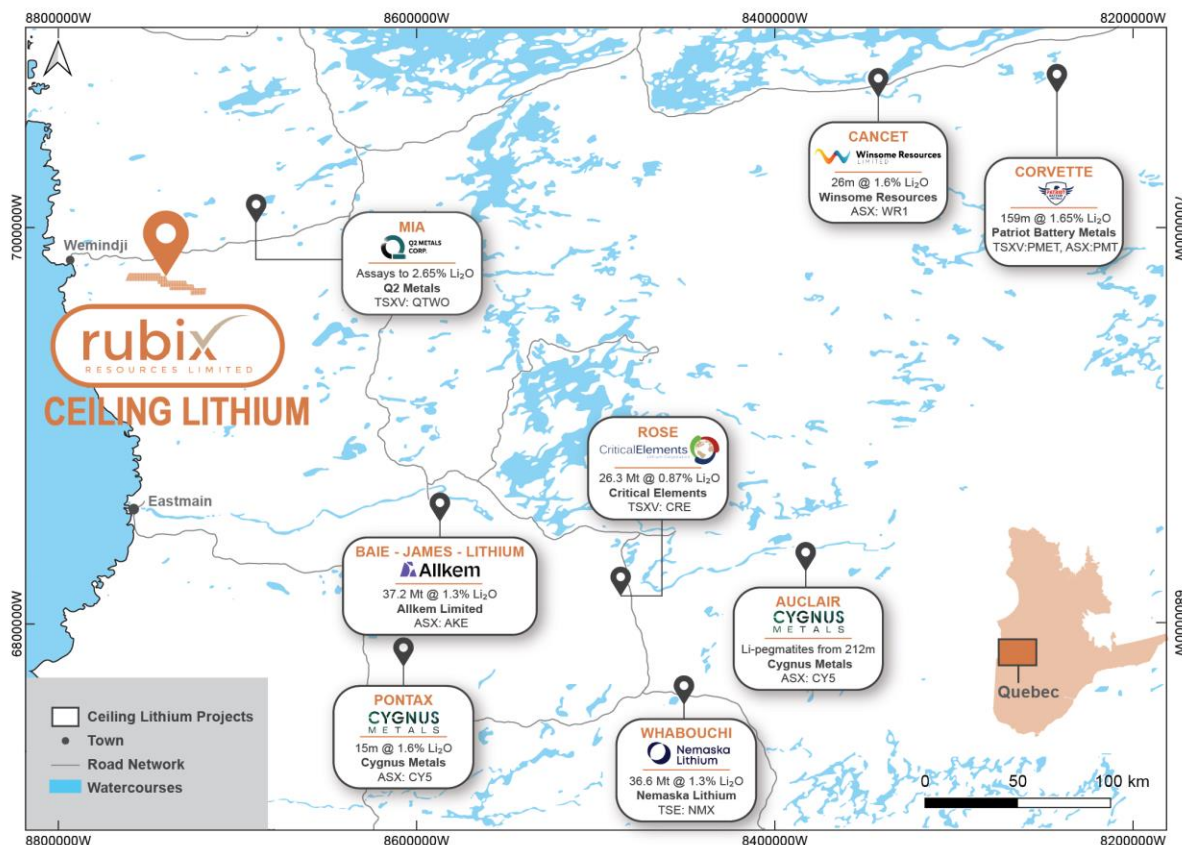


Figure 3 – James Bay advanced lithium projects and prospects
