**Notice under Section 708A(5)(e) of the Corporations Act 2001 (Cth)**

RTG Mining Inc. (TSX: RTG, ASX: RTG) ("**RTG**" or the "**Company**") advises that it has issued 81,037,020 new CHESS Depository Interests ("**CDIs**") (representing 81,037,020 fully paid ordinary shares in the share capital of the Company) at an issue price of A\$0.048 per CDI ("**Placement CDIs**") pursuant to the private placement to institutional and sophisticated investors announced on 4 July 2023. The Placement CDIs rank equally with other CDIs on issue.

RTG gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("**Corporations Act**") as modified by ASIC Class Order 14/827 that:

- the Placement CDIs were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
