

Date of AGM and Closing Date for Director Nominations

In accordance with ASX Listing Rule 3.13.1, Spectur Limited (ASX: SP3) (**Spectur** or the **Company**) advises that the Company's Annual General Meeting (**AGM**) will be held on Thursday 23 November 2023. A Notice of Meeting for the AGM is being prepared by the Company and will be announced to ASX and provided to Shareholders before 25 October 2023.

An item of business at the AGM will be the election of directors. Existing Non-Executive Director Bilyana Smith will retire by rotation and will stand for re-election.

The Directors have considered the issue of Board composition and the mix of skills needed to effectively govern and lead the organisation, balanced with the imperative of prudent cashflow management and containing non-operational (governance) expenses.

The Board is seeking to recruit an additional Non-Executive Director to the Board and calls for nominations from suitably qualified candidates.

In assessing nominations, the Board will evaluate candidates against its desired skill set. Regard will be had for a range of qualities and experience, including:

- C-suite or executive-level experience with P&L responsibility;
- Experience in business development & marketing in business, government and infrastructure contexts;
- A proven track record in growing and scaling businesses, particularly in the technology and related hardware space;
- Experience and understanding of capital markets and investor relations;
- A high level of commercial acumen;
- Able to bring a board-level mindset to issues of governance, strategy, risk and leading the Managing Director;

In addition to the above, a preparedness to make an initial investment in Spectur shares, and/or accept payment of board fees in Spectur shares for a period of time (subject to shareholder approval) will be highly regarded.

In accordance with rule 6.2(f) of the Company's Constitution, the closing date for the receipt of nominations for the election of Directors is Wednesday 4 October 2023. Any nominations must be received at the Spectur registered office no later than **5.00pm (AWST) on Wednesday 4 October 2023**.

Should the Board decide that a suitable Non-Executive Director nomination has been received, its intention is to offer the candidate for election at the upcoming AGM.
