# WESTERN LEFROY FARM-IN & JOINT VENTURE UPDATE

Lefroy Exploration Limited ('Lefroy' or 'the Company') (ASX:LEX) advises that it has been appointed as the Joint Venture Manager of the Western Lefroy Farm-In and Joint Venture Agreement (JV).

The JV is held between Lefroy's 100%-owned subsidiary, Hogans Pty Ltd (49%), and St Ives Gold Mining Company Pty Ltd (51%), a wholly-owned subsidiary of Gold Fields Limited (JSE:GFI).

GFI has provided notice to Lefroy that it would not satisfy the Stage 2 Farm-in requirement to attain a 70% interest.

The next phase of the operation will include the establishment of a Management Committee between the JVA parties to guide future priority activities.

Lefroy will review the related final drilling data upon receiving it from GFI and will provide further information in the Company's next quarterly announcement.

This announcement has been authorised for release by the Board of Directors.
