

Appointment of Dr Casey Blundell as CEO

Rubix Resources Limited (ASX: RB6, "**Rubix**" or the "**Company**") is pleased to announce the appointment of Dr Casey Blundell as Chief Executive Officer, effective immediately.

In addition to the AIG, she maintains active membership with the AusIMM, Australian Society of Exploration Geophysicists (ASEG) and the Society of Economic Geologists (SEG).


