

## **Dropsuite Vesting of Performance Rights**

26 September 2023: Global cloud backup and archiving software provider Dropsuite Limited (ASX: DSE) ("Dropsuite" or the "Company") confirms the Board of Directors have resolved the issuance of 3,353,333 fully paid ordinary shares related to the performance rights granted under the 2020 Employee Long Term Incentive Plans (LTIP) for eligible employees following satisfaction of the below hurdles:

- Employees have been employed for a period of 36 months from the date of grant; and
- Share price achieved a 30-day volume weighted average price of at least AUD\$0.22 for a minimum of thirty days.
