# Large, fractionated pegmatite discovered at the Aero Property – James Bay, Canada

Outstanding start to JBY's maiden exploration program at the La Grande Project, Quebec

**Highlights:** 

- Extensive pegmatite outcrop named 'Avro' discovered at the Aero Property, part of JBY's La Grande Project portfolio in James Bay, Quebec, Canada.
- Outcrop has been observed over an area of ~400m in length and up to ~20m wide in sections, running east-west across the south-eastern segment of the property.
- The Avro pegmatite displays fractionation indicators and accessory minerals often associated with rare metal pegmatites.
- The pegmatite is interpreted to be open in all directions, where the outcrop extends under cover.
- Systematic grab sampling, rock sawing and channel sampling underway.
- The Avro pegmatite discovery is near a 4-season gravel road & power lines, facilitating efficient access and potential future operations.
- The Aero Property is a prospective lithium property located along trend from Winsome Resources' (ASX: WR1) Cancet Lithium Project and Patriot Battery Metals' (ASX: PMT) world-class CV5 deposit.

James Bay Minerals (ASX: **JBY**) ("**James Bay Minerals**" or "**the Company**") is pleased to advise that it has made a significant breakthrough in its maiden field exploration program at the highly prospective Aero Property, which forms part of the Company's La Grande Project, located in the prolific Eeyou Istchee-James Bay district in Quebec, Canada.

JBY, along with its exploration partner Breakaway Exploration (BXM), recently commenced its inaugural field exploration campaign, with a large continuous pegmatite outcrop identified in the first week of exploration activity. The pegmatite, which the field crew have named 'Avro', was discovered outcropping over an area of ~400m in length and up to ~20m wide in sections. Field crews are systematically working through the area mapping the pegmatite and collecting samples for testing.

The field program commenced near the south-eastern portion of the property, where a 4-season gravel road runs through the property. The Avro pegmatite was made more visible by recent wildfires that have burnt much of the property and cleared away shrub and brush, leading to almost an immediate discovery.

The Avro pegmatite dyke is generally white in colour and clearly stands out as a ridge several metres above the surrounding brown coloured biotite schist that it is injected into (Figures 1 and 2). It dips steeply to the north, sub-parallel to the foliation planes of the biotite schist. The pegmatite dyke consists of coarse-grained, well-developed crystals of plagioclase (albite), quartz, tourmaline and muscovite. BXM personnel are currently selecting grab samples systematically and rock saw channel sampling is underway, but no rock samples have been submitted for assay at this stage.

Interpretation of the pegmatite extent and mineralisation is in its early stages, and initial observations of tourmaline – a common accessory mineral in rare-metal pegmatites – is being used as an indicator for fractionation and vectoring, with the current interpretation being that it is a fractionated pegmatite derived from a nearby fertile granite. Portable XRF analysis will begin on site immediately to facilitate this and evolve the geological theory.

Further desktop studies and interpretations of satellite images and historic geophysical maps are currently being conducted by Breakaway Exploration Management (BXM) to assess additional interpreted pegmatites in the area.

An important field observation of the Avro pegmatite outcrop at Aero is that the pegmatite appears to plunge under low-lying cover along strike to the west and east. The Avro pegmatite outcrop is interpreted to remain open in both directions and is concealed beneath cover. Field work is continuing to focus throughout this part of the property in light of the discovery of the Avro pegmatite, road access and general ease of accessibility due to recent fires clearing ground cover and making outcrops easily visible.

## James Bay Executive Director, Andrew Dornan, commented:

"What a fantastic result for the Company to have identified a large pegmatite dyke at our Aero Property so early in our first field exploration program. This result is well ahead of expectation but not surprising considering that our properties were carefully selected due to their geological features being ideal for the formation of LCT pegmatites.

"We are very much looking forward to making further discoveries across the Aero Property as our inaugural field program continues."

## About the Aero Property

The Aero Prospect consists of 89 continuous claims covering an area of 4,365 hectares. The Aero Property has approximately 12km of deformation zones which are considered highly prospective for Lithium-Caesium-Tantalum (LCT) Pegmatites. The nearby Cancet (Winsome) and Corvette (Patriot) properties both have deformation zones running through their properties and both Winsome and Patriot have had significant exploration success along these zones.

A field program being undertaken by five personnel has been designed to map targeted areas of the Aero Property along with the collection of rock chips and completion of channel samples for analysis. The field program has commenced and will continue until first snow fall arrives (expected mid-October 2023).

Established infrastructure, in particular the sealed roads which run through the Property, allows for easy access.




Figure 3 - Aero Property Satellite Imagery.



## **Background on James Bay Minerals**

James Bay has acquired a 100% interest in one of the largest lithium exploration portfolios in the James Bay region, covering an area of 22,438Ha or 224km<sup>2</sup>. The Joule, Aero and Aqua properties are located in the La Grande sub province along trend from the Corvette deposit, where Patriot Battery Metals (ASX: PMT) recently reported a maiden Inferred Mineral Resource Estimate of 109.2Mt at 1.42% Li<sub>2</sub>O and 160ppm Ta<sub>2</sub>O<sub>5</sub> (0.40% Li<sub>2</sub>O cut-off grade).<sup>1</sup>

The Troilus Project is located further to the south sitting only 5km to the north of Sayona's Moblan Lithium Project and proximity to Winsome Resources' Sirmac-Clappier Project.




Figure 4 - James Bay Minerals' key lithium project locations in Quebec, Canada.

The flagship Joule Property encompasses a ~24km long prospective deformation zone along a regional fault which has been subject to minimal historical exploration. The eastern segment of the deformation zone extends for 14km and fan tails to reach a width up to 1.5km.

The Aero Prospect contains approximately 12km of deformation zones which are considered highly prospective for LCT pegmatites. Of note, the nearby Cancet (Winsome Resources Ltd) and Corvette (Patriot Battery Metals) properties both exhibit deformation zones upon which significant exploration success has occured<sup>1</sup>.

- Lying on greenstone belts in proximity to granites.
