### **A. Details of remuneration**

## REVIEW OF OPERATIONS

Norfolk Metals currently holds the Roger River Gold Project in Tasmania and the Orroroo Uranium Project in South Australia. Over the last 12 months the following activities occurred:

- **Orroroo Project confirmed Uranium mineralization via downhole geophysical survey**
- **Orroroo Project Gravity survey delineates distinct channels within the Wallaway Basin**
- **Norfolk progressing all permitting requirements to commence maiden drill program at the Orroroo Project**

- **Maiden drill program completed at Roger River Project**
- **Multiple native copper intersects observed at Roger River with copper screening analysis completed**
- **Further surface geochemical work undertaken to define future drill targets at Roger River**
- **Inaugural ESG report published for calendar year 2022**
- **Norfolk is continually reviewing potential projects, investments and acquisitions**

## **Orroroo Uranium Project**

Throughout 2023 Norfolk completed two geophysical programs within the boundaries of the Orroroo Project permit EL6552. The Company also progressed extensive stakeholder and community engagements throughout the preparation, duration and post completion of these programs. Throughout 2023 Norfolk become proud sponsors of the Orroroo Football and Netball Club, the Orroroo Golf Club and the upcoming 2023 Rural Women's Day to be held 14 October 2023 in Orroroo.

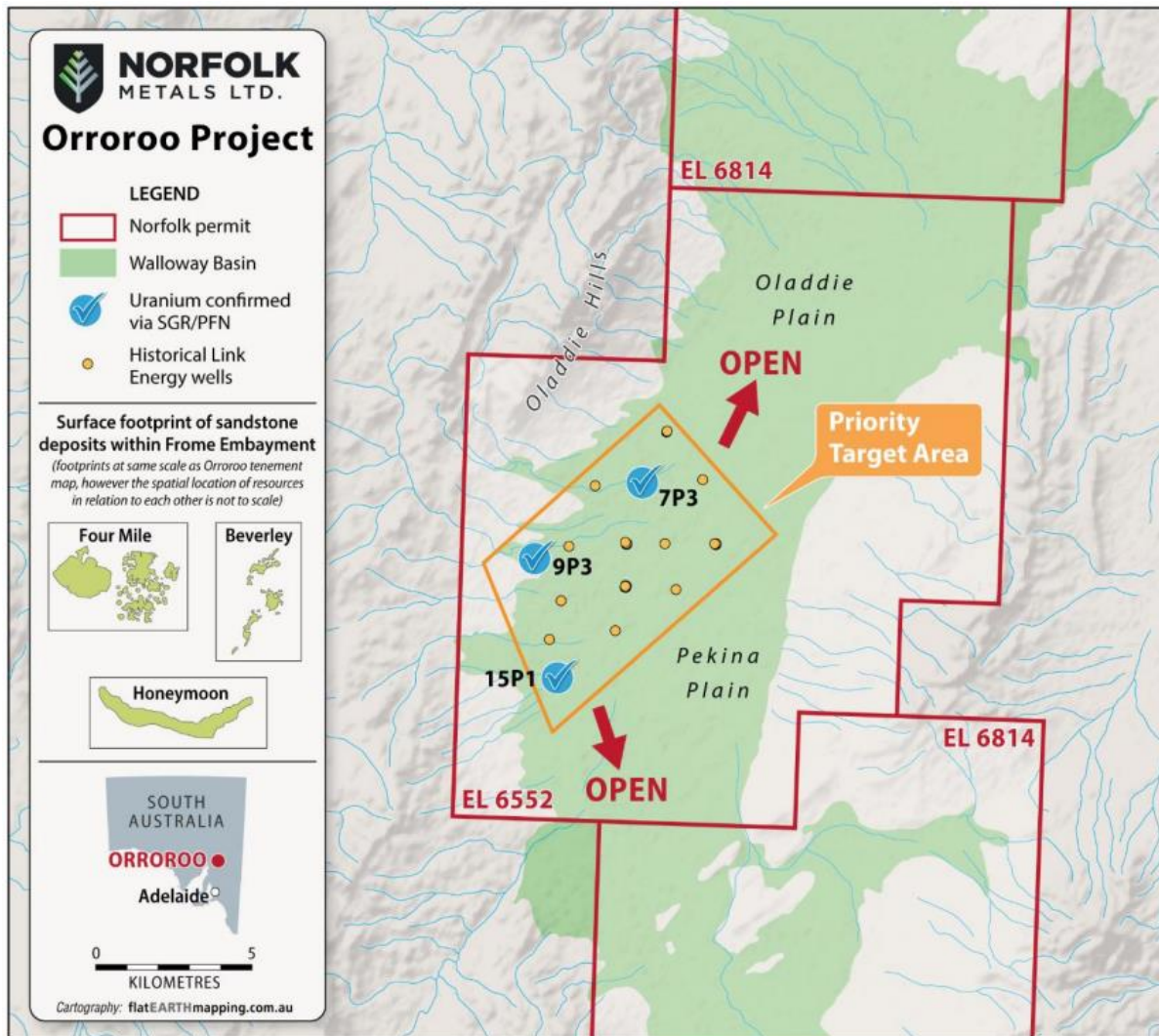
The upcoming milestone for Norfolk shareholders will be the maiden drill program at Orroroo of which the Company has well progressed on all of facets the required permitting. Norfolk board expects to update the shareholders in the imminent future with planning and expectations for the maiden drill program.

Reflecting on the success of the two geophysical programs completed in 2023; 27 February 2023 saw Norfolk report the downhole geophysical survey conducted at the Orroroo Project. Spectral Gamma and Prompt Fission Neutron (PFN) well logs recorded have been utilised for further exploration planning. The program was considered immensely successful on completion having confirmed the following:

1. Uranium occurrences in all three target zones (wells) of which the depths are potentially suitable for proven in-situ recovery methods;
2. Uranium peak reported at 650ppm pU3O8 within an interval of 192ppm pU3O8 over 0.5m from 112.59m via PFN in well 7P3 (Figure 1); and,
3. Uranium recorded from this survey at expected target depths obtained from historical holes supports the proposed "oxidised tails or interface zones" of roll-front uranium style mineralisation theory proposed by the Norfolk geology team.

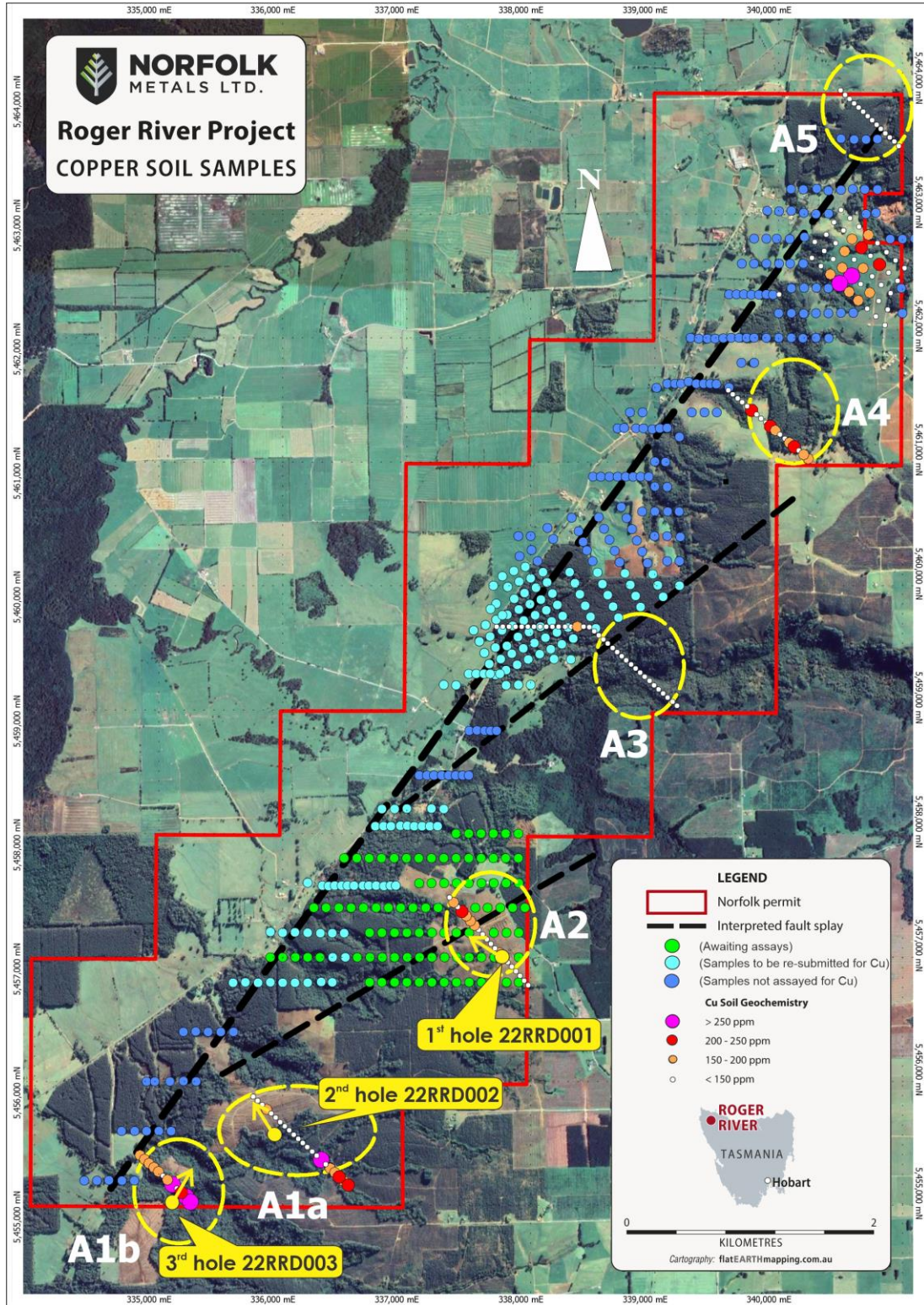
**Figure 2. First Derivative (1VD) gravity survey displaying two distinct channels**

The subsequent gravity survey reported on 6 July 2023 successfully delineated two distinct regional channels (Figure 2) along with potential paleochannel(s) within the Walloway Basin. This program further supports the Company geological model for Orroroo to potentially host sandstone hosted uranium similar to other known South Australian deposits. The delineation of the channels is encouraging progress; specifically, the Western Channel with sandstone hosted uranium potential modelled via three (3) primary datasets being;

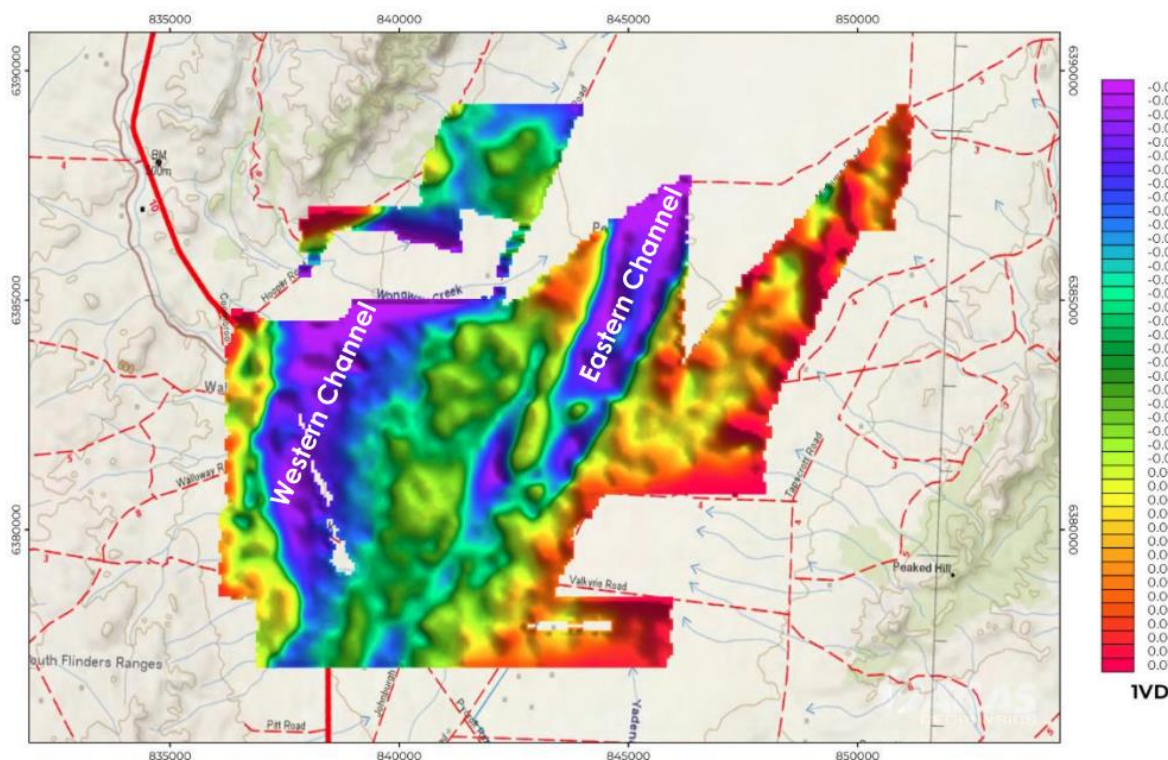
1. Historical drilling information (gamma anomalies and stratigraphic records);
2. Recent downhole geophysics of historical wells confirming the presence of uranium; and,
3. Gravity data interpretation.

The gravity data suggests two distinct lows with paleochannel potentials existing within the basin, shown as a broader Western Channel and a narrower Eastern Channel. Geological logs and cross sections of available drill

hole data suggest that the Western channel is a paleochannel characterized by a thick basal sandstone and coal horizon. The Western Channel displays a distinct REDOX Interface with similarities to the Yarramba paleochannel which is host to the Honeymoon uranium deposit.

## Roger River Project

For the 12-month reporting period to the 30 June 2023 the main objective was to drill test the coincident magnetic and gravity anomalies located along structural splays off the main Roger River Fault. It is an investigation to determine the possible structural control of mineralization and location of coarse native copper which may represent (and possibly be used as a vector to locate) a porphyry copper system that may indicate massive sulfide mineralization.

During the reporting period, Norfolk conducted the following exploration activities (Figure 3):

- Received and evaluated the results for the 121 orientation soil samples

- Conducted sizing sample analysis with ALS
- Completed a soil sampling survey around the A2 Anomaly

## Soil Orientation Program

Five orientation lines were designed over the 5 identified geophysical targets. The orientation lines were designed approximately perpendicular to the splay structures coming off the Roger River Fault.

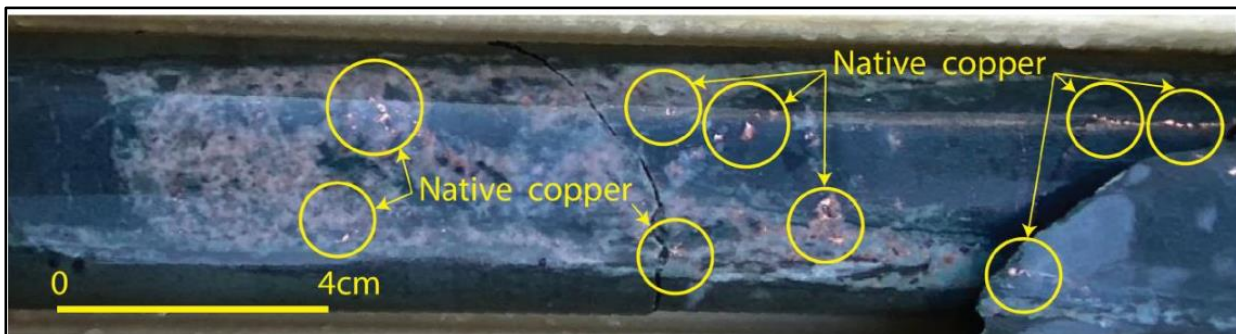
A total of 121 samples were collected for the soil orientation line study. Assay results for copper and gold for the soil orientation lines over the 5 geophysical targets are shown in Figure 3. Copper values greater than 250ppm were identified in samples across multiple orientation lines. The anomalous values appear to closely correlate to the interpreted positions of the splays, in particular Anomalies 2 & 4. This may suggest that the splays may have been 'active' and possibly acted as a pathway for hydrothermal fluids. To further investigate, a soil program has been completed to extend the initial orientation soil line over the A2 target.

## Diamond Drilling

Norfolk completed 3 holes for a total of 885.20m. The 3 holes were drilled to test the coincident magnetic and gravity anomalies along the fault splay from the main deep seated Roger River Fault structure.

### 22RRD-001

The first drillhole 22RRD-001 (drilled to 318.0m) was located in prospect A2 and targeted a coincident magnetic and gravity anomaly defined from surface geophysical surveys. The target was conceptual in nature and the drill hole was designed to better resolve the source of key geophysical units within the project area. Native copper was observed over discrete zones from 58.50m to 145.40m downhole depths. Native copper occurs as disseminations (1-3%) in the host rock (basalt) as well as disseminations in later quartz-carbonate veins overprinting the host rock. The narrow veins that contain native copper are commonly sub-parallel to the core axis (the hole path).

There appears to be strong alteration near the basalt and sediment contact (147.5m downhole) with magnetite potassium and hematite assemblage around silica-carbonate veins containing native copper. The intercalated basalt/sediment units (175.90m to 192.20m downhole) shows dense potassic-epidote-silica veins with disseminated pyrite. Some of the clasts within the sediments demonstrate flattening and suggest that compression/faulting could possibly be creating dilational zones. These type of dilational zones promote deformation with fractal opening that may allow mineralised fluids to accumulate.

Within the sedimentary units (209.60m to 318.0m EOH), several strongly laminated massive pyrite veins were observed. The veins are up to 4mm in thickness.

It has been suggested that the magnetic anomaly is represented by the magnetic basalt units and the gravity anomaly is possibly represented by the thick dense sedimentary units.

It has been recognized that the native copper is not pervasive throughout the core and has been strongest along the narrow quartz-carbonate veins as disseminated copper. However, it was also recognized that the coarse native copper may not be best represented in the assays using the standard fractions applied by the laboratory for the analysis. Consequently, a sizing study was completed to form the basis of Standard Practice for future reference.

As previously mentioned, the narrow veins in 22RRD-001 that contain native copper are commonly sub-parallel to the core axis (the hole path). Therefore, it may be possible that a hole drilled perpendicular to 22RRD-001 may intersect more vein sets with more significant grades.

## **22RRD-002**

Drill hole 22RRD-002 was drilled to test Target A1a over a coincident magnetic and gravity anomaly. Only the magnetic bodies were modelled due to the lack of gravity data points necessary to construct a model body. The hole was drilled to a depth of 220m and mainly intersected unmineralized sedimentary units on top of the hole (down to 51.50m) and fresh vesicular/propylitic basalt to the end of the hole.

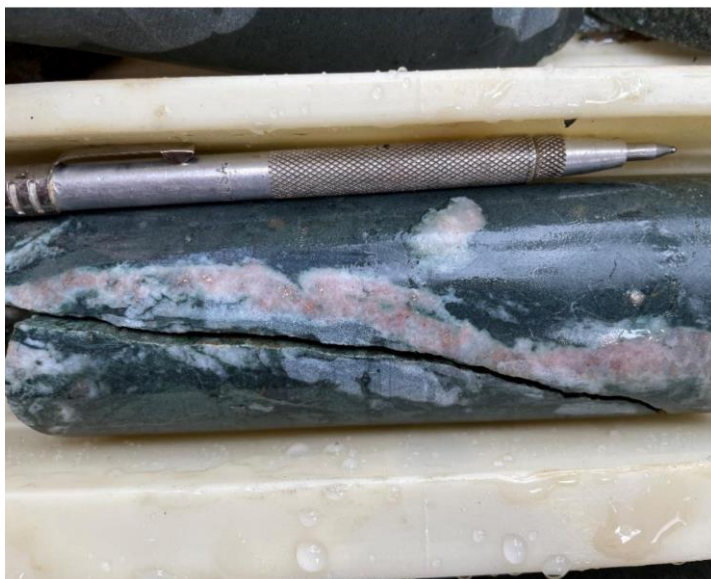
The basaltic units were non-magnetic and no significant mineralisation was observed. Therefore, no samples were submitted for analysis. The basalt units observed in 22RRD-002 appear to be lower in the basalt sequence to the basalt units observed in RRD-001. The hole did not reconcile with the anomalies identified from the magnetic model.

## **22RRD-003**

Drill hole 22RRD-003 was drilled to test the magnetic anomaly A1b near the junction of the interpreted splay and the main Roger River Fault down to 342.70m. The target was also conceptual in nature and the drill hole was designed to test the source of key magnetic feature and its association with possible mineralization. Native copper was observed over discrete zones from 102.0m to 137.80m downhole depths. Native copper occurs as clast in wall rock (<1%), as disseminations (1-3%) in the host rock (basalt) as well as disseminations (<1%) in later quartz-carbonate veins overprinting the host rock.

There appears to be stronger copper mineralization (1-3%) from 212.4m to 216.4m downhole where copper has been observed consistently along the basalt fractures.

The interbedded sediment units (263.05m to 338.90m) partly hematitic, shows dense potassic-epidote-silica veins with minor disseminated pyrite (<1%).

The highest Cu assays obtained from 22RRD-003 have been tabulated below:

Again, the native copper is not pervasive throughout the core and is reflected by the assay results. However, from the sizing study (see below), there is a possibility of underestimating the grade due to the coarse nature of the copper minerals and the size/weight of the samples analysed.

## Sample Sizing Analysis

Norfolk conducted geochemical analysis study on the maiden drilling program to better understand the distribution of the native copper and determine the best suited analytical method to represent the grades in the core.

In all sample intervals, the native copper observed in the whole/uncut drill core is not as pervasive in the basalt wall rock. Consequently, the visually concentrated copper in each sample interval is from the narrow veinlets resulting in 0.05% to 0.18% Cu assays. However, to get a better understanding of the possible variability that the coarse native Cu may cause in the assay results, selected pulverized samples were re-homogenized and resent for Cu screening analysis using 50g (original sample 25g) aqua regia 4-acid digest. This provided larger sample size for duplicates with each sample being analysed four times via aqua regia and four acids for Cu.

The main differences in the analytical methods were as follows:

1. The original analysis (ME – MS 61r) was based on core samples pulverised but not sieved down to 0.25g sample mass (analysed for 61 elements using 4-acid digest with ICP-MS Finish).
2. The second analysis ME-ICP44 was analysed using homogenised samples (not screened) pulverised down to 50g sample mass (analysed for 44 elements using 4-acid digest with ICP Finish).
3. The third method involved initially screening the samples (0.5kg homogenised sample) passing through -75 microns to determine the coarse fractions and then analysing the total sample mass. The screening method relies on separating all the metal contained in the sample pulp on top of a 75micron screen analysing it in its entirety and also analysing the minus fraction and bringing this into the calculations for Cu Total.

It was concluded from the study that the larger the mass analysed the better the results. For practicality and cost effectiveness, it is the intent of the company that for future drilling whereby native copper have been observed in the core, the ME-ICP44 analysis method using 50g sample mass will be implemented.

## Soil Sampling around Target A2

A soil sampling survey based on a 200 x 100m grid around the A2 anomaly was completed. A total of 98 samples were collected covering an area of approximately 1.2km x 1.5km over the interpreted splay from the Roger River Fault. The aim of the survey was to extend the anomalous Cu results obtained from the orientation line over the A2 target as well as provide a possible surface trend or strike to the native Cu mineralization intersected in 22RRD-001.

It has been previously suggested that the occurrence of native copper may act as a vector, commonly as a halo of around 500m, to a porphyry style deposit. The completed soil survey may possibly support the above suggestion and provide a trend towards such deposit.

All multi-element assays are awaiting.

## Conclusion

Two of the three holes drilled during the reporting period intersected native copper. The copper is contained within the basalt and carbonate veinlets. Some of the clasts within the sediments demonstrates flattening and suggesting compression/faulting that could possibly create dilational zones. These type of dilational zones promote deformation with fractal opening that may allow mineralized fluids to accumulate.

The narrow veins in 22RRD-001 and 22RRD-003 that contain native copper are commonly sub-parallel to the core axis (the hole path), therefore, it may be possible that a hole drilled perpendicular/scissors to the above drill holes may intersect more vein sets with more significant grades. The results from proposal hole will assist to determine the strategy and order of priorities for the remaining Norfolk drill targets.

With the size fraction sample study, it was concluded that the larger the mass analysed the better the results, but screening every sample would be laborious and costly. It is the intent of the company that for future drilling whereby native copper have been observed in the core, the ME-ICP44 analysis method using 50g sample mass will be implemented.

## ESG Report

### GENERAL INFORMATION

Norfolk Metals Limited (Norfolk or the Company) is a for-profit company limited by shares, domiciled and incorporated in Australia. These financial statements comprise of the Company and its subsidiaries (collectively the Group). The financial statements are presented in the Australian currency. The nature of operations and principal activities of the Company are described in the Directors' Report.

### 1. BASIS OF PREPARATION

#### 1.1.1. Reporting Basis and Conventions

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001. Norfolk Metals Limited is a listed public company, incorporated and domiciled in Australia. All amounts are presented in Australian dollars.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in the financial statements containing relevant and reliable information about transactions, events and conditions to which they apply. Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards (IFRS). Material accounting policies adopted in the preparation of these financial statements are presented below. They have been consistently applied unless otherwise stated.

The financial statements have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

#### 1.1.2. Comparatives

When required by accounting standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

#### 1.1.3. Basis of Consolidation

The consolidated financial statements comprise the financial statements of Norfolk Metals ('the Company') and its subsidiary ('the Group'). Subsidiaries are those entities over which the Company has the power to govern the financial and operating policies so as to obtain benefits from their activities. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether a Company controls another entity.

In preparing the consolidated financial statements, all intercompany balances and transactions, income and expenses and profit and losses resulting from intra-company transactions have been eliminated in full. Unrealised losses are also eliminated unless costs cannot be recovered.

### 1.1.4. Going Concern

The financial report has been prepared on the going concern basis, which contemplates the continuity of normal business activity and the realisation of assets and the settlement of liabilities in the ordinary course of business.

The Group incurred a loss for the year of \$771,491 (2022: \$649,946) and net cash outflows from operating activities of \$541,864 (2022: \$214,933). As at 30 June 2023, the Group has a working capital surplus of \$3,181,362 (2022: \$4,555,268).

The directors have prepared a cash flow forecast, which indicates that the Group will have sufficient cash flows to meet all commitments and working capital requirements for the 12-month period from the date of signing this financial report.

Based on the cash flow forecasts, the directors are satisfied that the going concern basis of preparation is appropriate.

## SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### a. Accounting Principles

The financial statements incorporate all of the assets, liabilities and results of the Norfolk Metals Limited. The Company has one subsidiary.

### b. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown as borrowings in current liabilities on the statement of financial position.

### c. Trade and Other Receivables

Trade and other receivables include amounts due from customers for goods sold and services performed in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Trade and other receivables are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any expected credit loss.

### d. Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the Company that remain unpaid at the end of the reporting period. Due to their short-term nature they are measured at amortised cost and are not discounted. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

### e. Provisions and Employee Benefits

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

When the Company expects some or all of a provision to be reimbursed, for example under an insurance contract, the reimbursement is recognised as a separate asset but only when the reimbursement is virtually certain. The expense relating to any provision is presented in the statement of comprehensive income net of any reimbursement.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the reporting date using a discounted cash flow methodology. The risks specific to the provision are factored into the cash flows and as such a risk-free corporate bond rate relative to the expected life of the provision is used as a discount rate. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects the time value of money and the risks specific to the liability. The increase in the provision resulting from the passage of time is recognised in finance costs.

#### Employee leave benefits

(i) Wages, salaries, annual leave and sick leave

Liabilities for wages and salaries, including non-monetary benefits and annual leave expected to be settled within 12 months of the reporting date are recognised in respect of employees' services up to the reporting date. Liabilities for annual leave expected to be settled within 12 months of the reporting date are recognised in the current provision for the employee benefits. They are measured at the amounts expected to be paid when the liabilities are settled. Expenses for non-accumulating sick leave are recognised when the leave is taken and are measured at the rates paid or payable. For annual leave, expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currencies that match, as closely as possible, the estimated future cash outflows.

(ii) Long Service Leave

The liability for long service leave is recognised and measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date. Consideration is given to expected future wage and salary levels, experience of employee departures, and periods of service. Expected future payments are discounted using market yields at the reporting date on corporate bonds with terms to maturity and currencies that match, as closely as possible, the estimated future cash outflows.

#### f. Issued Capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

#### g. Income Tax

Current tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities based on the current period's taxable income. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted by the reporting date.

Deferred income tax is provided on all temporary differences at the reporting date between the tax bases of assets, liabilities and their carrying amounts for financial statements purposes.

Deferred income tax assets are recognised for all deductible temporary differences, carry-forward of unused tax credits and unused tax losses, to the extent that it is probable that taxable profit will be available against which the deductible temporary differences and the carry-forward of unused tax credits and unused tax losses can be utilised.

Deferred income tax assets and liabilities are measured at the tax rates that are expected to apply to the year when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted at the reporting date.

Unrecognised deferred income tax assets are reassessed at each reporting date and are recognised to the extent that it has become probable that future taxable profit will allow the deferred tax asset to be recovered.

#### Tax consolidation legislation

The consolidated entity has applied the stand alone taxpayer approach in determining the appropriate amount of current taxes and deferred taxes to allocate to members of the tax consolidated group. The current and deferred tax amounts are measured in a systematic manner that is consistent with the broad principles in AASB 112 Income Taxes.

Members of the tax consolidated group have not entered into a tax funding agreement and as no current tax assets or liabilities or deferred tax assets are recognised in relation to tax losses or unused tax credits, no contributions or distributions are required to be made under AASB Int 1052 Tax Consolidation Accounting.

#### **h. Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from financing and investing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

#### **i. Borrowings and Borrowing Costs**

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in profit or loss over the period of the borrowings using the effective interest method.

Borrowings are derecognised when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as other income or finance costs.

Borrowings are classified as current liabilities unless the Company has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

Borrowing costs include interest expense calculated using the effective interest method, finance charges in respect of finance leases, and exchange differences arising from foreign currency borrowings to the extent that they are regarded as an adjustment to interest costs.

Borrowing costs are expensed as incurred, except for borrowing costs incurred as part of the cost of the construction of a qualifying asset, which are capitalised until the asset is ready for its intended use or sale.

#### **j. Financial Instruments**

##### *Recognition, initial measurement and recognition*

Financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the financial instrument. Financial instruments (except for trade receivables) are measured initially at fair value adjusted by transactions costs, except for those carried "at fair value through profit or loss", in which case transaction costs are expensed to profit or loss. Where available, quoted prices in an active market are used to determine the fair value. In other circumstances, valuation techniques are adopted. Subsequent measurement of financial assets and financial liabilities are described below.

Trade receivables (if applicable) are initially measured at the transaction price if the receivables do not contain a significant financing component in accordance with AASB 15.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### Classification and subsequent measurement

##### Financial assets

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with AASB 15, all financial assets are initially measured at fair value adjusted for transaction costs (where applicable).

For the purpose of subsequent measurement, financial assets other than those designated and effective as hedging instruments, are classified into the following categories upon initial recognition:

- amortised cost;
- fair value through other comprehensive income (FVOCI); and
- fair value through profit or loss (FVPL).

Classifications are determined by both:

- The contractual cash flow characteristics of the financial assets; and
- The entities business model for managing the financial asset.

##### Financial assets at amortised cost

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVPL):

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash flows; and
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The Company's cash and cash equivalents, trade and most other receivables fall into this category of financial instruments.

##### Financial assets at fair value through other comprehensive income

The Company measures debt instruments at fair value through OCI if both of the following conditions are met:

- The contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding; and
- The financial asset is held within a business model with the objective of both holding to collect contractual cash flows and selling the financial asset.

For debt instruments at fair value through OCI, interest income, foreign exchange revaluation and impairment losses or reversals are recognised in the statement of profit or loss and computed in the same manner as for financial assets measured at amortised cost. The remaining fair value changes are recognised in OCI.

Upon initial recognition, the Company can elect to classify irrevocably its equity investments as equity instruments designated at fair value through OCI when they meet the definition of equity under AASB 132 Financial Instruments: Presentation and are not held for trading.

##### Financial assets at fair value through profit or loss (FVPL)

Financial assets at fair value through profit or loss include financial assets held for trading, financial assets designated upon initial recognition at fair value through profit or loss, or financial assets mandatorily required to be measured at fair value. Financial assets are classified as held for trading if they are acquired for the purpose of selling or repurchasing in the near term.

#### k. Financial liabilities

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings, payables, or as derivatives designated as hedging instruments in an effective hedge, as appropriate.

Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Company designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for derivatives and financial liabilities designated at FVPL, which are carried subsequently at fair value with gains or losses recognised in profit or loss.

All interest-related charges and, if applicable, gains and losses arising on changes in fair value are recognised in profit or loss.

#### l. Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the company's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the company's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

#### m. Segment Reporting

Operating segments are now reported in a manner that is consistent with the internal reporting to the Chief Operating Decision Maker, which has been identified by the Company as the Managing Director and other members of the Board of Directors.

The Company has identified its operating segment based on the internal reports that are reviewed and used by the Board of Directors in assessing performance and determining the allocation of resources. Reportable segments disclosed are based on aggregating operating segments, where the segments have similar characteristics. For the current reporting period, the Company's sole activity was mineral exploration and resource development wholly within Australia, which is its only reportable segment.

The reportable segment is represented by the financial statements forming this financial report.

#### n. Exploration Expenditure

Exploration and evaluation costs are accumulated and accounted for separately on an area of interest basis. An area of interest is represented by an exploration project, which may include multiple tenements within a single geographic region.

For each area of interest, the Company makes an election regarding its treatment of exploration and evaluation expenditure (including the costs of tenement acquisitions) and whether it will be charged to the income statement as incurred, under the expense category "exploration expenditure" (or other appropriate expense category), or capitalised as an exploration and evaluation asset, or a combination thereof.

An exploration and evaluation asset can only be recognised in relation to an area of interest if the following conditions are satisfied:

a) the rights to tenure of the area of interest are current; and

- the exploration and evaluation expenditures are expected to be recouped through successful development and exploitation of the area of interest, or alternatively, by its sale; and
- exploration and evaluation activities in the area of interest have not at the end of the reporting period reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves, and active and significant operations in, or in relation to, the area of interest are continuing.

Capitalised exploration and evaluation expenditures are recorded as an exploration asset at cost less impairment charges. All capitalised exploration and evaluation expenditure are monitored for indicators of impairment. Where an impairment indicator is identified, an assessment is performed for each area of interest to which the exploration and evaluation expenditure is attributed. To the extent that capitalised expenditure is not expected to be recovered it is charged to the income statement.

#### **o. Critical Accounting Estimates and Judgements**

The Directors evaluate estimates and judgements incorporated into the financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Company.

##### Deferred Exploration and evaluation Expenditure

Exploration and evaluation expenditure includes prepaid project acquisition costs that have been capitalised on the basis that the Company will complete the acquisition of mineral licenses / leases where it has entered into a binding share purchase agreement. Key judgements are applied in considering costs to be capitalised which includes determining expenditures directly related to these activities and allocating overheads between those that are expensed and capitalised.

##### Share-based payment transactions:

The Company measures the cost of equity-settled transactions with employees and third parties by reference to the fair value of the equity instruments at the date at which they are granted. The fair value at the grant date is determined using the Black and Scholes option pricing model taking into account the terms and conditions upon which the instruments were granted.

#### **p. Impairment of non-financial assets other than goodwill**

The Company assesses at each balance date whether there is an indication that an asset may be impaired. If any such indication exists, or when annual impairment testing for an asset is required, the Company makes an estimate of the asset's recoverable amount.

An asset's recoverable amount is the higher of its fair value less costs to sell and its value in use and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or Company of assets and the asset's value in use cannot be estimated to be close to its fair value. In such cases the asset is tested for impairment as part of the cash-generating unit to which it belongs. When the carrying amount of an asset or cash-generating unit exceeds its recoverable amount, the asset or cash-generating unit is considered impaired and is written down to its recoverable amount.

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Impairment losses relating to continuing operations are recognised in those expense categories consistent with the function of the impaired asset unless the asset is carried at revalued amount (in which case the impairment loss is treated as a revaluation decrease).

An assessment is also made at each balance date as to whether there is any indication that previously recognised impairment losses may no longer exist or may have decreased. If such indication exists, the recoverable amount is estimated. A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the asset's recoverable amount since the last impairment loss was recognised. If that is the case the carrying amount of the asset is increased to its recoverable amount. That increased amount cannot exceed the carrying amount that would have been determined, net of depreciation, had no impairment loss been recognised for the asset in prior years.

Such reversal is recognised in profit or loss unless the asset is carried at revalued amount, in which case the reversal is treated as a revaluation increase. After such a reversal the depreciation charge is adjusted in future years to allocate the asset's revised carrying amount, less any residual value, on a systematic basis over its remaining useful life.

#### **q. New and amended accounting standards**

The Company has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

#### **r. New Accounting Standards and Interpretations not yet mandatory or early adopted**

A number of new standards, amendments to standards and interpretations issued by the AASB which are not yet mandatorily applicable to the Company have not been applied in preparing these financial statements. The Company has not elected to adopt any new Accounting Standards or Interpretations prior to their applicable date of implementation.

### 13. FINANCIAL INSTRUMENTS

#### **(i) FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES**

The Group's principal financial instruments comprise cash and short-term deposits. The main purpose of the financial instruments is to earn the maximum amount of interest at a low risk to the Group. The Group also has other financial instruments such as trade debtors and creditors which arise directly from its operations. For the period under review, it has been the Group's policy not to trade in financial instruments.

The directors' overall risk management strategy seeks to assist the Group in meeting its financial targets, whilst minimising potential adverse effects on financial performance.

Risk management policies are approved and reviewed by the Board of Directors on a regular basis. These include the credit risk policies and future cash flow requirements.

#### **Financial Risk Exposures and Management**

The main risks arising from the Group's financial instruments are interest rate risk and credit risk. The board reviews and agrees policies for managing each of these risks and they are summarised below:

##### **(a) Foreign Currency Risk**

The Group is not exposed to fluctuations in foreign currencies.

##### **(b) Interest Rate Risk**

The Group is exposed to movements in market interest rates on short term deposits. The policy is to monitor the interest rate yield curve out to 120 days to ensure a balance is maintained between the liquidity of cash assets and the interest rate return. The Group does not currently have short or long-term debt, and therefore this risk is minimal.

##### **Sensitivity analysis**

An increase of 50 basis points in interest rates would not have had a material impact on the Consolidated Entity's profit or loss.

##### **(c) Credit Risk**

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Group. The Group has adopted the policy of only dealing with credit worthy counterparties and obtaining sufficient collateral or other security where appropriate, as a means of mitigating the risk of financial loss from defaults.

The Group does not have any significant credit risk exposure to any single counterparty or any Group of counterparties having similar characteristics.
