- (a) The Company does not have a Remuneration Committee. The Company's Remuneration and Nomination Committee Charter provides for the creation of a Remuneration Committee (if it is considered it will benefit the Company), with at least three members, a majority of whom are independent Directors, and which must be chaired by an independent Director.
- (b) Due to the size and nature of the existing board and the magnitude of the Company's operations the Company currently has no Remuneration Committee. In accordance with the Company's Board Charter, the Board carries out the duties that would ordinarily be carried out by the Remuneration Committee under the Remuneration and Nomination Committee Charter including the following processes to set the level and composition of remuneration for Directors and senior executives and ensuring that such remuneration is appropriate and not excessive:
 - (i) the Board devotes time at Board meetings to assess the level and composition of remuneration for Directors and senior executives; and
 - (ii) the Board will oversee the evaluation of the remuneration of the Company's senior executives annually. The evaluation will be based on specific criteria. The Company will disclose for each financial year whether or not the relevant annual performance evaluations have been conducted.

Recommendation 8.2

A listed entity should separately disclose its policies and practices regarding the remuneration of non-executive directors and the remuneration of executive directors and other senior executives.

The Company's Remuneration and Nomination Committee Charter requires the Board to disclose its policies and practices regarding the remuneration of Directors and senior executive. This information is disclosed in the Company's Annual Report.

Recommendation 8.3

A listed entity which has an equity-based remuneration scheme should:

- (a) have a policy on whether participants are permitted to enter into transactions (whether through the use of derivatives or otherwise) which limit the economic risk of participating in the scheme; and
- (b) disclose that policy or a summary of it.

The Company has adopted a Performance Rights Plan and Employee Option Plan (**Plans**). A summary of each of the Plans is set out in the Prospectus dated 5 April 2022, a copy of which can be found on Company's website. The Company updated its Plans at Annual General Meeting held on 24 November 2022, a summary of the updated Plan which is set out under Schedule 1 in the Notice of Annual General Meeting dated 19 October 2022, a copy of which can be found on Company's website.

Performance Rights or Options may be issued under the relevant Plan subject to vesting conditions. Under the Company's Securities Trading Policy, participants are prohibited from engaging in hedging arrangements, dealing in derivatives or entering into other arrangements which vary economic risk related to any unvested entitlements in the Company's securities. The Company's Securities Trading Policy is available on the Company's website.
