

COMPLETION OF ENTITLEMENT OFFER SHORTFALL

PERTH, AUSTRALIA; 2 October 2023: Hazer Group Ltd ("Hazer" or "the Company") (ASX: HZR) advises that further to the Company's announcement of 21 August 2023, and Appendices 2A of 22 August 2023 and 25 August 2023 (as they relate to the outstanding shortfall allocations), that it has today completed the issue of the remaining pro-rata entitlement offer shortfall allocations, with the issuance of 1,437,952 New Shares and 718,978 New Options.
