Results of Annual General Meeting

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, Redcastle Resources Limited (ASX: RC1) ("Redcastle" or "the Company") advises the details of the resolutions and the proxies received in respect of each resolution put to the Annual General Meeting of shareholders held 6 October 2023 are set out in the attached proxy summary.

All resolutions were conducted by a poll. Resolutions 2, 3, 4 and 5 were carried.

Due to more than 25% of votes cast in respect of Resolution 1 being against adoption of the Company's Remuneration Report, the Company received a second strike and was required to put the Conditional Spill Resolution set out in Resolution 5 to shareholders. Resolution 5 was carried and as a result a separate Spill Meeting will be required, which will be convened within 90 days in accordance with the requirements of the Corporations Act 2001 (Cth).
