PROTEAN ENERGY LIMITED – UPCOMING ANNUAL GENERAL MEETING OF SHAREHOLDERS

However, votes and questions may also be submitted during the Meeting.

Once logged in you can also lodge your proxy vote online by clicking on the "Vote" tab.
