Shares Issued and Cleansing Notice

Further to the ASX Announcement on 6 October 2023, Accelerate Resources Limited (ASX: AX8) (“Accelerate” or “the Company”) issued 85,400,439 fully paid ordinary shares at \$0.02 each to a range of professional and sophisticated investors under Tranche 1 of the Placement.
