NOTICE GIVEN UNDER SECTION 708A(5)(E) OF THE CORPORATIONS ACT

West Africa's newest gold producer Tietto Minerals (ASX: TIE) (**Tietto** or the **Company**) hereby gives notice to ASX for the purpose of section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that on 16 October 2023 it issued and allotted a total of 40,162,961 fully paid ordinary shares in the capital of the Company (**Shares**) without disclosure under Part 6D.2 of the Corporations Act.
