

- The tenure covers +50 km strike of Lake Johnston Greenstone Belt, which consolidates the southern region for the first time
- Total tenement area of 356 km²
- Favourable komatiite host for nickel sulphide extends for the entire length of Project






Lake Johnston | A Significant Land Package

- The Lake Johnston Greenstone Belt is geologically similar to the prolific nickel & lithium bearing Southern Cross-Forrestania Greenstone Belt
- TG Metals has the most significant land package held by one company within the Lake Johnston Greenstone Belt, 356 km² and growing with acquisitions
- +50 km strike of Greenstone Belt
- Strong conductors now being drilled south of the past producing Maggie Hays and Emily Anne Ni sulphide deposits
- Lithium potential in recent soil sampling

Located between two prolific Greenstone Belts






New Nickel Sulphide Focus

3 Priority Prospects - New Drilling

- New high powered ground TEM over the central tenements of the Bremer Range prospect detected 9 conductors of interest*
- 3 prospects selected for initial drill testing, Highfield, LJC137
 and Cathkin South
- RC pre-collar with Diamond core tails. Commenced drilling on Highfield target
- Multiple conductor targets allows prioritization of current drilling and flexibility for multiple drilling phases, testing each target and allowing follow-up drilling based on visual results as we go

Targeted exploration strategy producing results




New Nickel Sulphide Focus

Drill testing conductors

- Re-interpretation of data and new high powered ground
 TEM has identified nickel sulphide targets*
- Three (3) prospects currently being drill tested
- Conductors supported by historical surface and oxide subsurface geochemistry and prospective contact positions
- Drill testing deeper than ever before and in locations overlooked by previous explorers – conductor depths similar to the mined Maggie Hays and Emily Anne deposits immediately to the north
- RC and Diamond core assay results early November

Leveraging off past exploration with improved techniques






Lithium Prospectivity

- Lithium exploration RC drilling commenced
- The area hosts known lithium-caesium-tantalum (LCT) pegmatites (Medcalf, Mt Day)
- Recent soil sampling has defined Lithium anomalies* at the Lake Johnston Project. Program expanded to the east – assays awaited
- Neighbours have defined spodumene bearing pegmatites in proximal lithium prospects, most notably Medcalf (Charger Metals NL)
- Shallow RC drilling program underway to define orientations, thickness and grade
- Revisiting historical drilling for pegmatite intercepts


Maiden drilling campaign on lithium soil anomalies



Nickel-Cobalt Laterite Deposits

- Opportunity for low cost mining and toll treating to generate early cash flow
- Initial drilling delivered high grades up to 3.23%Ni
- Potential for simple beneficiation and transport to proximal processing (<140 km to Ravensthorpe Nickel Operations)
- Initial aircore drilling on Area 3 completed assays confirmed high grade areas do exist, samples collected for metallurgical testwork*
- 4 additional areas remain untested by TG Metals


