QUOTATION OF NEW OPTIONS

Grand Gulf Energy Ltd (ASX:GGE) ("Grand Gulf" or the "Company") refers to the ASX announcement dated 25 August 2023 whereby the Company announced that it had received firm commitments from existing and new sophisticated and professional investors (**Investors**) to raise a total of \$3,200,000 (before costs) through the issue of a total of 400,000,000 Shares (**Placement Shares**) at an issue price of \$0.008 per Share (**Placement**).

The Company offered Investors the opportunity to apply for one (1) free attaching option to acquire a Share (**Placement Options**) for every four (4) Placement Shares subscribed for by Investors.

The Company also agreed to issue 120,000,000 options to acquire Shares to the lead manager of the Placement, CPS Capital Group Pty Ltd (**Broker Options**) and 5,000,000 options to acquire Shares to S3 Consortium Pty Ltd (**S3 Consortium Options**), on the same terms as the Placement Options.

The Placement Options, Broker Options and S3 Consortium Options are together referred to as the **New Options**.

The Company wishes to advise that the ASX announcement on 25 August 2023 wherein the New Options were described to be "unlisted", was incorrect. The relevant notice of meeting released to the Company's ASX platform on 6 September 2023 and options prospectus lodged with the ASIC and ASX on 10 October 2023 indicated an application for quotation for the New Options was to be, and has been, undertaken.

The relevant Appendix 2A's were lodged with ASX on 19 October 2023.

Further to the application for quotation on 19 October 2023, please find attached to this announcement the distribution schedule and the top 20 option holders report for the New Options.
