

## Appointment of Director

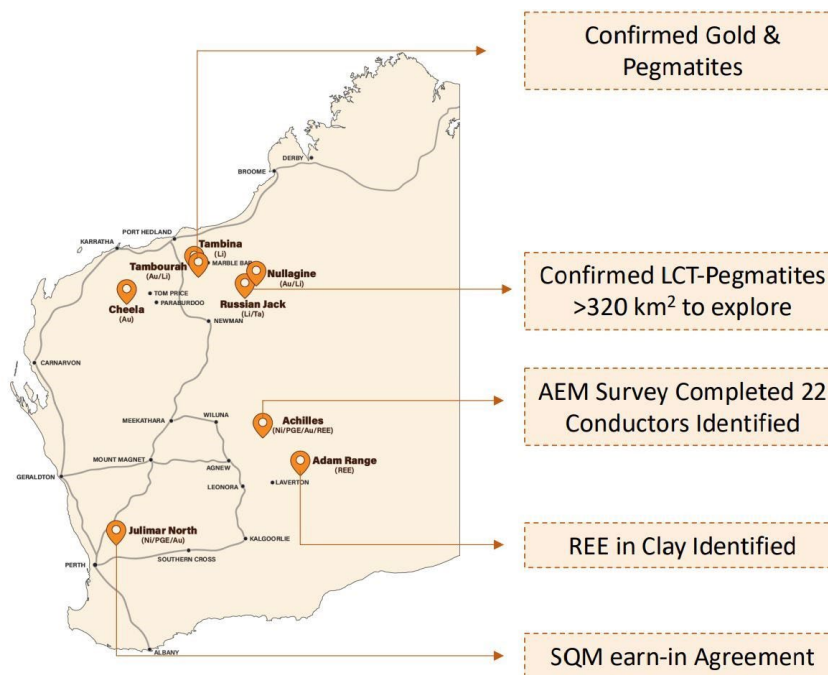


Figure 1: Tambourah Metals Project Locations
