Yes, the Company has entered into a standby equity commitment with SBC Global Investment Fund which will provide up to A\$10 million in equity financing over a period of 36 months as announced on 21 July 2023. In addition, the Company has capacity to raise further funds under ASX Listing Rules and is currently progressing further funding discussions to meet its planned activities and expenditure commitments.
