Your proxy form must be received by 12:00pm (Brisbane Time) on Monday, 27 November 2023, being not less than 48 hours before the commencement of the Meeting. Any proxy forms received after that time will not be valid for the Meeting.

Shareholders may submit questions in advance of the Meeting by email to the Company Secretary at mike@hiddenpersuaders.com by 5.00pm (AEST) on Monday, 27 November 2023. Shareholders who attend the Meeting will also have the opportunity to submit questions during the Meeting.
