Operations Update

Gryphon Wapiti 16-02-65-08 well successfully spuds and Certus Caroline 01-27-33-05 well flowing back to sales.

Perth, Western Australia – 27th October 2023 – Stonehorse Energy Limited (ASX: SHE) is pleased to announce the successful spud of the Gryphon, Wapiti well located in West-Central Alberta, Canada. The Pad preparation, rig mobilisation and spud was completed on schedule with drilling operations currently underway.

Key Highlights:

Wapiti 16-02-65-08 drill:

- Location completed, rig moved in and commenced drilling operations on October 22nd.
- Anticipate well to reach a planned depth of 10,760 ft (3280 m) by early November.
- First Oil flow-back target late November / early December.
- Legacy oil productive reservoir Good analog producing fields north and south of prospective area.
- Well target control Strong offset analog vertical wells with major E&P operations in the area.
- Planned for 1 Mile (1600 m) lateral wellbore in reservoir completed with a multi-stage slick water frac stimulation.
- Available infrastructure and access to take-away capacity for gas processing and oil sales.

Caroline 01-27-33-05 first production:

- Successful multi day flow-back and in-test was completed on October 8th with good initial production results.
- Equipped and tied well into permanent production facilities on October 18th.
- Brought well online October 19th and currently producing natural gas and condensate to sales.
