Mustera Property Group Ltd (**Mustera** or the **Company**) is pleased to provide an update on its operational activities during the September 2023 Quarter (the **Quarter**).


HIGHLIGHTS

- Mustera continued with its sales and marketing campaign for the Company's flagship project, Forbes Residences (Forbes or the Project).
- 2. The Company secured \$6.51m in apartment sales during the Quarter for the Project.
- 3. Construction has progressed on the Project with finishes and fit out, plus service installation ongoing.

1. Forbes Residences, 10 Forbes Road, Applecross

The project is in the advanced stages of completion with scaffolding progressively being dismantled with craneage and access platforms still in place. Structure is completed. Internal ceilings and walls substantially complete, continuation of services with fire and hydraulic commenced to level 12 with lower floors progressing. External glazed windows, doors and joinery progressing. Waterproofing is completed to concrete roof decks and masonry planters progressing. Landscaping to roof top deck substantially complete, swimming pool outer shell complete, external claddings continuing. Tiling, painting and joinery progressing. The control unit is now 95% complete.





In addition to the construction activities the Company continued with its sales and marketing campaign for the Project. The Company sold 3 apartments which has secured an additional \$6.51m in sales during the Quarter for the Project.

2. Corporate Commentary

Summary of expenditure incurred

In accordance with Listing Rule 4.7C.1, the Company spent approx. A\$8.4 million on operating costs, comprised of project development and construction costs of approx. A\$8.2 million for Forbes Residences, and occupancy costs of approx. A\$200K for its investment properties (being 15 McCabe Street and the Shoalwater Shopping Centre).

The Company incurred interest expenses of approx. A\$1m during the quarter. Additionally, corporate overheads totalling A\$169K for the quarter include advertising and marketing costs of A\$7K, staff costs of A\$98K and administrative costs of A\$64K.

Subsequent to the Quarter, the Company has refinanced several of its existing debt facilities and as part of the refinance, approximately \$1.42m is now available to Mustera and will be utilised as working capital for the Group.
