CLEANSING NOTICE

This notice is given by Strickland Metals Limited (**Issuer**), under section 708A(5)(e) of the Corporations Act 2001 (**Act**).

The Issuer today issued 500,000 fully paid ordinary shares in Strickland (**Shares**) at an issue price of \$0.04 per share issued on the exercise of options as set out in the Appendix 2A dated 3 November 2023.
