YARMANY LITHIUM EXPLORATION UPDATE

HIGHLIGHTS:

- Aboriginal Heritage Agreement signed and clearance survey completed over priority lithium target areas
- Maiden lithium drilling program to commence immediately following completion of earthworks
- Drill areas surveyed include the large (1km x 140m) F-camp pegmatite target unit which has a favourable geochemical lithium-caesium-tantalum (LCT) signature for lithium mineralisation

Metal Hawk Limited (**ASX: MHK**, "Metal Hawk", "the Company") is pleased to advise that it has signed a Heritage Agreement and successfully completed a Heritage Clearance Survey with the Marlinyu Ghoorlie Native Title Claimants over the Yarmany Project, located 40km north-west of Coolgardie in Western Australia. A drilling contractor has been secured and drilling activities are due to commence as soon as site preparations are complete.

Metal Hawk's Managing Director Will Belbin commented: "Metal Hawk would like to thank all the Traditional Owners who participated in the heritage survey. The timely execution of a Heritage Agreement followed by a smoothly conducted survey enables us to proceed with our maiden lithium drill program at Yarmany."

"We are very excited to start drilling this compelling pegmatite target developed by our expert lithium consultant Dr David 'Rowdy' Rawlings. The F-camp pegmatite is extremely weathered at surface and has potential scale and highly favourable geochemistry. We also look forward to continuing regional exploration activities on the extensive tenement package."

The Yarmany Project covers an area of 282km² with 50km of strike along the Ida Fault, a major regional structure and crustal boundary between the Kalgoorlie and Youanmi Terranes. Since acquiring the project from Horizon Minerals in July 2023, the Company has generated a number of quality lithium and nickel targets.

F-CAMP LITHIUM PROSPECT




Figure 1. Yarmany Project F-camp prospect surface geochemistry

Recent mapping and geochemical sampling by Metal Hawk outlined a large lithium pegmatite target (Figure 1) with over 1km of strike length and up to 140m wide at the F-camp prospect, located 16km south of the northern boundary of the Yarmany Project. Elevated lithium and pathfinder geochemistry including Cs, Ta, Rb and Be support geological field observations and



indicates strong potential for pegmatite-hosted lithium-caesium-tantalum (LCT) mineralisation (see ASX announcement 26 October 2023).

NEXT STEPS

- Mobilisation of earthmoving equipment to site shortly.
- A drilling contractor has been secured and is scheduled to commence drilling as soon as site preparation is completed.
- Aircore drilling is designed to define pegmatite geometry and establish depth of weathering and will be followed by deeper RC drilling.




Figure 2. Yarmany Project in relation to other lithium projects in the Kalgoorlie Terrane




Figure 3. Metal Hawk's goldfields and Albany-Fraser project locations
