NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

Raiden Resources Limited (ASX: RDN DAX: YM4) (**Company**) confirms that today it issued 40,965,208 fully paid ordinary shares in the capital of the Company (**Shares**) to Welcome Exploration Pty Ltd for the acquisition of the (5) Andover tenements. Further information is contained in the ASX announcement released on 28 June 2023. The shares issued today have been approved by shareholders at the General Meeting held 22 September 2023.

The Company issued 8,238,861 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.03044 per Issued Shares following the exercise of Upfront Option under the Agreement with Arrow Minerals Limited, for 100% of the Lithium-Cesium-Tantalum rights over the Arrow Project, further information is contained in the ASX announcement release dated 6 November 2023.

The Company issued 1,028,000 fully paid ordinary shares in the capital of the Company (**Shares**) at an issue price of \$0.015 per Issued Shares following the exercise of 1,028,000 listed options (RDNOA) with expiry date of 30 November 2024. The options were issued under the Company's Loyalty Options Offer, further information is contained in the ASX announcement release dated 26 October 2022.

The Company issued 5,000,000 Listed Options in the existing RDNOA class at an exercise price of \$0.015 expiring on 30 November 2024 to consultants, refer to Appendix 2A.

In respect of the Share issue, the Company gives notice pursuant to section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**) that:

1. the Company issued the Shares without disclosure under Part 6D.2 of the Corporations Act; and
2. as at the date of this notice, the Company has complied with:
 - a) the provisions of Chapter 2M of the Corporations Act as they apply to the Company; and
 - b) section 674 of the Corporations Act; and
3. as at the date of this notice, there is no information to be disclosed which is excluded information (as defined in section 708A(7) and 708A(8) of the Corporations Act), other than is set out below:
 - a) as announced on 9 August 2023, the Company is continuing with its strategy of assessing opportunities to divest non-core assets within its portfolio, whilst advancing the lithium potential over its Pilbara projects and metallurgical work at the Mt Sholl Ni-Cu-PGE project. The Company is currently in early-stage, incomplete and confidential negotiations with third parties with respect to the proposed terms of any divestment of its non-core assets. Until the material commercial terms have been agreed, there can be no guarantee that such negotiations will lead to the announcement or completion of a binding agreement. The Company will keep the market informed in accordance with its continuous disclosure obligations;
 - b) the Company continues to identify and review other commercial opportunities for the Company which complement the Company's existing projects and activities. Negotiations with third parties are early stage, incomplete and confidential. There can be no certainty that any agreement or agreements will be reached, or that any transaction will eventuate.

- c) As previously announced, the Company is continuing its portfolio wide mapping and sampling program and results will be analysed, collated and continue to be released to the market in accordance with the Company's continuous disclosure obligations.
