# Encouraging First Assay Results from Picha Copper Project

Australian battery minerals explorer, Firetail Resources Limited (**Firetail** or **the Company**; ASX: **FTL**) is pleased to provide an update on the maiden drilling program at the Picha Copper Project in Peru.

Assay results from the first 62 metres of the first drill hole at the Cobremani target have been received.

### **Highlights include:**

- Best assay result in 23PCMD0001 of 13m @ 2.81% Cu and 27.1g/t Ag from 2m (using a cut-off of 0.1% Cu);
- Other significant results include 3.9m @ 0.27% Cu and 4.68g/t Ag from 23.7m and 2.5m @ 0.22% Cu and 9.76g/t Ag from 41.9m;
- Drill assay result confirms the near-surface supergene mineralisation located in earlier surface channel sampling at Cobremani target (41.6m @ 1.12% Cu and 22.85g/t Ag);
- 23PCMD0001 completed to 500m depth having tested a resistivity anomaly.
- First drill hole (23PMCD0001) at Maricate target has commenced, to test a surface channel sample of **17.6m @ 1.95% Cu**.

The planned diamond drilling program comprises of ten drill holes for ~5,000m in total and Firetail expects the drill program will be approximately 3-4 months in duration, with assays expected regularly during the drilling campaign.

### **Executive Chairman, Brett Grosvenor, commented:**

"I am delighted with the progress made by the team in Peru, with the first drill hole completed and the second underway. I have just returned from site, where I was able to gain a better understanding of all the activities in person, and to spend time engaging and building relationships with the local team and community.

"These initial assay results in the first 62m of the first drill hole at the Picha Copper Project is an excellent start to the drilling campaign and they are supportive of our interpretation of the mineralisation. Ultimately this gives us great confidence in the potential of this asset.

"Work continues on site, and we are looking forward to bringing regular updates on the assays as they are received."




Figure 3: Cross-section of 23PCMD0001, Cobremani Target, with geological interpretation




Figure 4: Plan view of 23PCMD0001 at Cobremani target



### Cobremani Target

The first drillhole (23PCMD0001) of the program has been completed at the Cobremani target where a surface geochemical anomaly has been identified including a channel sample of **41.6m @ 1.12% Cu and 22.85g/t Ag.** 

Assay results have been received from the first 62m of 23PCMD0001 with the most significant results highlighted in the table below.

The drill hole was also targeting a resistivity anomaly which was intersected between 250m and 300m downhole that appears to be caused by moderate propylitic and argilliic alteration and trace dissemenated pyrite. No visible copper mineralisation has been observed associated with the resistivity anomaly.

The drillhole has predominantly intersected andesitic volcanics of the Tacaza Group. The first 60m of the drillhole intersected occasional hydrothermal breccias with secondary copper including malachite and chalcocite (see example in Figure 2 above). Between 65m and 225m downhole depth the andesites have been consistently hematite altered with opaline silica veinlets, weak silicia-chlorite alteration and minor breccias. Thereafter, the andesites display propyltic and argillic alteration with silica and calcite veins, minor breccias and trace disseminated pyrite.

The remainder of the hole is now being cut and sampled and will be sent to the assay laboratory later this month.

### Maricate Target

Drilling has now commenced on the second hole of the program at the Maricate target with 23PMCD0001 currently at a depth of around 200m.

The Charaque Project is subject to an Earn-in Agreement with leading global gold and copper producer Barrick Gold Corporation<sup>3</sup>.




Figure 5: Picha and Charaque Copper Projects in Peru

### **Drill Targets at Picha**




Figure 6: Picha drill program underway and DIA approved area

The drilling permit for Picha<sup>4</sup> allows drilling of up to 120 holes, comprising up to 40 drill platforms with three holes planned per platform (see Figure 6 below).

The maiden diamond drilling program, comprising around 5,000m, is underway and is designed to test four targets within the Effective Area – Cobremani, Cumbre Coya, Maricate and Fundicion<sup>5</sup>.

Details of these high-potential targets for the drilling program are as follows:

- Cobremani Target (completed) Drill-hole PDH-04 (surface geochemical anomaly including channel sample of 41.6m @1.12% Cu and 22.85g/t Ag, and strong geophysical anomaly at ~200m depth).
- Maricate Target (commenced) Drill-hole PDH-35 (surface geochemical anomaly including channel sample of 17.6m @ 1.95% Cu).
- Cumbre Coya Target Drill-hole PDH-48 (surface geochemical anomaly including channel sample of 32.85m @ 0.61% Cu and 209 g/t Ag and chargeability anomaly) and Drill-hole PDH-76 (geochemical and chargeability anomaly at ~250m depth).
- Fundicion Target Drill-hole PDH-70 (chargeability anomaly at ~250m depth), Drill-hole PDH-87 (geophysical chargeability anomaly at ~250m depth), Drill-hole PDH-91 (geophysical chargeability anomaly at ~300m depth) and drill holes PDH-102 and 112 (chargeability anomaly at ~150m depth).

### **Next steps at Picha**

- Completion of drillhole 23PMCD0001 at Maricate Target
- Finalise drill pads in preparation for drilling next holes at Fundicion and Cumbre Coya Targets
- Submit remaining samples for drillhole 23PCMD0001 from Cobremani Target
