# **PRE-QUOTATION DISCLOSURE**

Freedom Care Group Holdings Limited (ACN 059 950 337) (ASX:FCG), previously known as Resource Generation Limited (**Company**) provides the following confirmations to satisfy conditions for admission of the Company's securities to quotation on ASX.

Capitalised terms in this announcement have the corresponding meaning as given in the Company's replacement prospectus dated 11 September 2023, as supplemented by the supplementary prospectus dated 18 October 2023 (**Prospectus**), unless otherwise specified.

# COMPLETION OF OFFER AND SECONDARY OFFERS

The Company confirms that all conditions to the Offer and the Secondary Offers (collectively, the **Offers**) under the Prospectus have been satisfied and the Offers have now closed. The Company has issued:

- (a) 16,000,000 Shares and 3,200,000 Options under the Offer to raise \$3,200,000 (before costs);
- (b) 82,500,000 Shares and 15,000,000 Options to the Vendors in consideration for the Acquisition under the Consideration Offer;
- (c) 210,000 Shares to select employees of Freedom Care under the Employee Offer;
- (d) 3,571,429 Shares to the Convertible Note holders under the Noteholder Offer;
- (e) 396,825 Options to Director Keith Glennan and 500,000 Options and 450,000 Shares to Director Zoran Grujic under the Director Offer; and
- (f) 583,335 Shares and 1,500,000 Options to Novus Capital Limited (and/or its nominees) under the Lead Manager Offer.

The Options which were issued under the Prospectus are exercisable at \$0.25 each on or before 27 November 2025.



## **COMPLETION OF ACQUISITIONS**

The Company confirms that:

- (a) all conditions precedent to the Acquisition have been satisfied and completion has occurred under the Acquisition Agreement with the Company acquiring 100% of the issued share capital of Freedom Care and issuing 82,500,000 Shares and 15,000,000 Options to the Vendors under the Consideration Offer; and
- (b) all conditions precedent under the KDC Share Sale Agreement have been satisfied and completion has occurred under the KDC Share Sale Agreement with Freedom Care acquiring 29 fully paid ordinary shares in KDC (representing a 29% interest in KDC) and paying the KDC Vendor \$1,450,000 in cash.

#### CHANGE OF COMPANY NAME

The Company confirms that its change of name to Freedom Care Group Holdings Limited took effect on 24<sup>th</sup> November 2023.
