## **RESULTS OF ANNUAL GENERAL MEETING OF SHAREHOLDERS**

**MinRex Resources Limited (ASX: MRR) ("MinRex"** or "the **Company"**) held its Annual General Meeting of Shareholders of the Company today, 30 November 2023 at Level 2, 7 Havelock Street, West Perth WA.

Resolutions 2, 4, 5, 6, 7, 8, 10 and 11 were passed on a poll. Resolution 1 was not passed and accordingly the Company received a first strike in relation to its Remuneration Report.

Resolutions 3 and 9 were withdrawn at the Annual General Meeting due to Mr Robert Boston's resignation as Managing Director and Chief Executive Officer.
