The Strategic Growth Retention Rights (Retention Rights) are a one-off issue under the Company's Equity Incentive Plan (Plan) to Mr Raleigh Finlayson, Managing Director for Genesis. They were issued in two tranches, expiring on 31 December 2028. Tranche 1 has a 4 year performance period to 30 June 2027 and Tranche 2 has a 5 year performance period to 30 June 2028. The Retention Rights are structured such that they will only vest and convert into shares if Mr Finlayson remains employed by the Company for the respective 4 and 5 year periods and the performance measures are also achieved. The performance measures are structured to align with shareholder interests and include share price growth, relative TSR growth, reserve growth and production growth.
