The performance rights issued under the Nolans Project Success Plan will not vest and the underlying securities will not be issued unless the performance and vesting conditions as set by the Board have been satisfied. The performance rights issued under the Retention and Capability Plan will not be issued unless the vesting period as set by the Board has been satisfied.
