

ASX Announcement 15 December 2023

ENTITLEMENT ISSUE – ISSUE OF SHORTFALL SHARES, OPTIONS

Rent.com.au Limited (ASX:RNT) ('Rent.com.au' or 'the Company'), Australia's website made for renters, confirms that it has largely completed its non-renounceable entitlement issue ("Rights Issue") following the issue of most of the remaining ordinary shares and options to RM Corporate Finance Pty Ltd ("Underwriter") and nominees of the Underwriter.

The Rights Issue offered Eligible Shareholders the opportunity to subscribe for 1 new Share for every 4.5 Shares held at the record date at an issue price of \$0.017 per Share together with 1 free Attaching Option (exercise price \$0.04 and expiry date of 31 December 2025) for every 2 Shares subscribed for (the "Offer"). The proceeds of approximately \$1.95 million (before costs) will mainly be applied to continued commercialisation of RentPay.

In total, 114,480,201 ordinary shares and 67,240,069 options will be issued under the Rights Issue. The Company has applied for quotation of the options (code RNTO). The list of the top 20 holders and the distribution of holdings for the 65,769,481 options that have been issued to date are outlined in the tables included at Appendix 1.

In total, existing shareholders have taken up more than 90% of the Rights Issue shares either via taking up their entitlements or via taking shortfall shares. The following table summarises the position:

Following the issue of all the Entitlement Offer shares, entities controlled by Mr Bevan Slattery will hold 104,640,712 shares representing 16.6% of the ordinary shares of the Company.

"This very strong show of support from our shareholders, Board and management is greatly encouraging and provides us with the funding to really go after our growth goals in the short term. We've got a joint marketing campaign underway which is driving incremental sign ups as well as a strong pipeline of agent opportunities for us to convert which sets us up for a strong next quarter. In addition, we've received our R&D tax refund and fully repaid the advance from Radium Capital, providing additional funds for us to deploy," concluded Mr Bader.
