

ISSUE OF SHORTFALL SHARES UNDER THE UNDERWRITING AGREEMENT - UPDATED

Peregrine Gold Limited ("**Peregrine**" or the "**Company**") advises that additional cleared funds were received by the Company prior to the Options expiring on 24 December 2023. An additional 518,302 Options have subsequently been converted to ordinary shares in the Company.

Underwriting of Options
