Appendix 2A Correction & Cleansing Notice

DRA Global Limited (ASX / JSE: DRA) ("DRA" or "the Company") advises that the Appendix 2A released on 15 December 2023 incorrectly stated that all of the 192,481 shares to be listed on 22 December were to be issued as a result of the exercise of DRAAH (option expiring 01-APR-2026 ex nil).

The correct information is that the 192,481 shares have been issued following the exercise of the following options:

By the Company giving this notice, a sale of the Issued Shares noted above will fall within the exemption in section 708A(5) of the Act.
