Swift is pleased to announce the Activities Report and Appendix 4C Cash flow Report for the quarter ended 31 December 2023.

Q2 Highlights

- Cash position increased to \$2.5m with receipt of R&D tax refund and partial sale of holdings in MXO
- Swift's Lenders, Pure Asset Management Fund, converted Warrants reducing Swift's loan facility by \$261,000
- Swift continued push into Aged Care sector with long term contract wins with Toosey Aged Care and St Andrews Ballina and Byron Bay facilities
- St Andrews sites will be the first sites positioned to utilise the Swift and Checked in Care integrated product
- Total Swift Access sales of circa 11,500 rooms since product launch



Operations

Swift has continued to secure and deploy rooms in its target sectors of Mining and Aged Care. Since launching its Swift Access product in 2022, Swift has contracted 11,489 rooms across these sectors. Mining sales have grown steadily to 7% of the market, and Aged Care sales growth is accelerating following Covid shutdowns and as the market responds to new Aged Care Quality Standards regulations.



The Mining and Resources sector continues to show significant potential for growth. Swift's team are responding to multiple pricing proposals for Swift Access for potential customers across Australia. During the period, the team continued installation of contracted work with our tier 1 customer base, including Inpex, Mineral Resources and Iluka. The continued rollout to Mineral Resources sites sees Swift Access now available to over 4,000 screens across the Mineral Resources portfolio.

Swift attended the ACCPA National Conference during the period, building upon Swift's market presence in the industry. On the back of the conference, Swift entered into agreements with Toosey Aged Care in Tasmania and St Andrews for their two sites Ballina and Byron Bay. Swift continues to see high levels of activity in this sector and looks forward to updating shareholders on its progress throughout 2024.

Swift will attend the Aged Care Technology Summit NSW in March this year. Building upon its partnership, Swift and Checked in Care will be amongst a handful of operators at the event with a stand showcasing our product portfolio to some of the key industry decision-makers.

During the period, Swift continued to invest in its suite of products. Swift developed its new ACE subscription package, which is gaining significant traction in the Aged Care sector; the ACE subscription package gives residents access to unique features and tools for inclusivity and communication and specialised content curated for residential aged care at pricing that is accessible to the market while offering a premium entertainment upgrade option. Swift has taken on board industry feedback and insights to develop ACE to help solve many issues present for Aged Care providers today.

Swift continues to enhance its product portfolio, with the next generation of Swift Access being developed for release in 2024. The next generation of Swift Access will deliver an unprecedented level of personalised experience for residents in Aged Care, further simplifying their access to information and helping to build a community and reduce isolation.

The next generation will also be available to Swift's other key sectors, including Mining, Oil and Gas.

Cash Flow Commentary

Net Cash gained from operating activities for the December quarter was \$0.9m, headlined by a \$1.4m receipt of R&D tax refund during the period. Cash receipts were slightly lower during the period of \$4.45m, largely due to the timing of project-related invoices; cash receipts were consistent year on year. During the period \$4.95m was spent on operating costs including \$2.99m to deliver revenues during the period, staff costs of \$1.34m, administration and corporate costs of \$0.41m, advertising and marketing of \$0.01m and net interest expenses of \$0.2m.

Net cash used in investing activities was \$107,000, with \$43,000 for capital purchases largely related to purchasing of equipment for sales contracts and \$411,000 for internal product development. \$347,000 was received during the period for the sale of MXO shares. Swift still holds $\sim 8.6 \text{m}$ MXO shares at the end of the period.

Net cash used in financing activities for the current quarter consisted of \$47,000 for office/facility leases.

Related party payments for the quarter were \$132,000, comprising wages for Executive and Non-Executive directors.

Swift operated in the one operating segment during the quarter.

Q3 Outlook

Swift will continue to deliver upon its contracted revenue in both the Mining and Resources and Aged Care sectors. Sales and marketing efforts will continue to target existing and new customers to secure contracts that build upon Swift's subscription revenue base through the sale of Swift Access. Swift will continue to build upon its partnerships across both sectors including investment in product development and integration of Swift's product roadmap to secure the future of Swift's product in both sectors.

Swift holds ~8.6 million shares in Motio Limited (ASX:MXO). Swift will continue to explore its options with these shares during FY24.
