

## icetana secures \$250,000 expansion deal through Canadian reseller Delco Security

## Highlights:

- icetana has received a US\$168,000 (~AUD\$250,000), five year order for its AI software solution from Canadian reseller Delco Security.
- This is the expansion of an existing contract due for renewal in April 2024.
- Deployment in the coming months will see the existing end user's site upgraded to icetana's latest version software.
- The SaaS order also includes a hardware component required to upgrade the end user's infrastructure.

icetana Limited (ASX:ICE "icetana" or "the Company") is pleased to announce a contract for software and hardware to be provided to security services vendor Delco Security (Delco).

The order has an aggregate value of US\$168,000 (circa AUD\$250,000), consisting of five years of software and support and the supply of upgraded hardware to facilitate the end user's migration to icetana's latest version software. The end user is a well-known Canadian university, one of icetana's key markets.

The contract is priced on a software as a service basis, contributing to icetana's focus on increasing annual recurring revenue through customer expansion sales. It will deliver a net increase of over AUD\$30,000 in the company's ARR.

Chief Executive Officer Kevin Brown said:

"Delco is our key partner in the Canadian market and I'm delighted to be working with them again on renewing this contract. It sees a long-standing customer choosing to expand the icetana footprint across more of their cameras, as a result of the value we've demonstrated to them over the past years. This is a key part of our strategy: we land a new deal and deliver such value that we then secure an expansion of cameras upon renewal."



## Material terms of commercial arrangements:

- The contractual arrangement disclosed in this announcement is between icetana and Delco, rather than the end user.
- Licensing will begin 1 April 2024, at the conclusion of the existing contract term.
- The icetana end user mentioned in this announcement is subject to the End User Licence Agreement as published on the icetana website.
- The payment terms from Delco to icetana for these orders are on 30 day terms and invoicing will occur annually. Delco has a strong payment history with icetana.
- The order includes supply of hardware and a five year term of software support and maintenance, and in aggregate is for a total contract value of US\$168,000 (~AUD\$250,000). Ongoing revenues beyond this initial period will be subject to a customer renewal. Going forward it is therefore possible that no revenue over and above the initial order value materialises from Delco pursuant to this commercial arrangement.
