Conrad Asia Energy Ltd (ASX: CRD) - Request for Trading Halt

Conrad Asia Energy Ltd (ASX: CRD) (the "**Company**") requests that the securities of the Company be placed in a trading halt with effect from the commencement of trading today, Wednesday 31 January 2024, pursuant to Listing Rule 17.1.
