Answer: No. Cash outflows will continue to be reduced with drilling and the Hualilan Scoping Study completed and the focus on desktop work for the PFS. The Company has significantly reduced costs across its operations with the current quarter the first to capture full cost savings associated with the restructure in Ecuador. Additionally, the estimated quarters of funding available calculation does not include item 2.5, which has a positive impact on cashflow of almost \$0.75M and will continue to have a positive impact in coming quarters.

Answer: During the quarter the company commenced a process aimed at procuring funding to complete the Hualian bankable Feasibility Study via either:
