1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The Company is currently trialling its Solar Coatings products with a number of prospective customers and anticipates converting some of these trials into sales. During the quarter the Company received a purchase order for its EyeFly3D product for USD \$223,000 and expects to deliver these orders in early 2024.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: Subsequent to the December Quarter, the Company received firm commitments from existing sophisticated and professional investors to raise \$600,000 (before costs) via an equity placement (see ASX announcement 30 January 2024)

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes. The Company believes that the future commercial opportunities for its films and coatings is significant. In addition, the company recently received purchase orders for its existing EyeFly3D product for USD \$223,000, detailed in 1 above.
