

Executive Appointment

White Cliff Minerals Limited (ASX: WCM) is pleased to announce the appointment of Mr. Eric Sondergaard ("Eric") as Country Manager for Canada. Erics appointment to the Company significantly improves OUR Canadian footprint and local expertise at a critical time as it focusses on its portfolio of uranium silver and copper projects in Northwest Canada.
