Completion of Placement and Cleansing Notice

The Directors of GBM Resources Limited (ASX:GBZ) (**GBM** or the **Company**) advise of the completion of the share placement announced to ASX on 20 December 2023 (**Placement**).

The Company advises of the issue today of the following securities in relation to the completion of the Placement:

- 55,555,550 options exercisable at 1.5 cents per share and expiring 15 March 2026 (Options) to unrelated parties subscribing for shares in the first tranche of the placement which completed on 27 December 2023;
- 49,405,555 ordinary fully paid shares and 24,702,777 Options issued to directors of the Company pursuant to the second tranche of the Placement;
- 51,333,333 ordinary fully paid shares and 25,666,666 Options issued to Collins St Convertible Notes Pty Ltd pursuant to the second tranche of the Placement; and

All of the abovementioned issues of securities were approved by the Company's shareholders at the General Meeting of Shareholder held on 11 March 2024.

The Company is in the process of finalizing the placement of shortfall securities with the assistance of Canaccord Genuity (Canaccord) pursuant to the non-renounceable pro-rata entitlement issue announced to ASX on 20 December 2023, and expects to issue the securities within the next seven days. GBM RESOURCES LIMITED SECONDARY TRADING NOTICE – NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001

This notice is given by GBM Resources Limited (ACN 124 752 745) ("GBM") under section 708A(5)(e) of the Corporations Act 2001 (Cth) ("the Act").
