DIVIDEND INVESTMENT PLAN ALLOCATION PRICE FOR 2024 INTERIM DIVIDEND

Wesfarmers Limited today announced that the allocation price for shares to be issued through the Dividend Investment Plan for the interim dividend to be paid in respect of the six-month period ended 31 December 2023 is \$66.3641.

The allocation price for shares to be issued has been determined in accordance with the rules of the Dividend Investment Plan. For the 2024 interim dividend, the allocation price was calculated as the average of the daily volume weighted average price of Wesfarmers Limited shares, excluding trades which are not considered to reflect normal supply and demand, on each of the 15 consecutive trading days during the period from 26 February 2024 to 15 March 2023 inclusive.

Based on audited data, shareholders representing 12.90 per cent of Wesfarmers Limited quoted shares on issue had a valid election to participate in the Dividend Investment Plan for the period.

Shares are expected to be issued to participants in the Dividend Investment Plan on 27 March 2024.
