

Secondary Trading Notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth)

Further to the Appendix 2A released today, Vmoto Limited (ASX: VMT) (**Company**) advises that it has issued 8,856,610 fully paid ordinary shares (**Shares**) to employees and consultants of the Company in recognition of their efforts and contribution and 861,111 Shares to certain consultants in lieu of cash payment for salaries.

The Company hereby provides notification under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Act**) of the issue. The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A of the Act. By giving this notice, a sale of the Shares noted above will fall within the exemption in section 708A(5) of the Act and they will be able to be traded immediately.

For the purposes of section 708A(6) of the Act, the Company gives notice that:

- (a) the Company issued the Shares without disclosure to investors under Part 6D.2 of the Act;
- (b) this notice is being given under section 708A(5)(e) of the Act;
- (c) as at the date of this notice, the Company has complied with:
 - (i) the provisions of Chapter 2M of the Act as they apply to the Company; and
 - (ii) sections 674 and 674A of the Act; and
- (d) as at the date of this notice, there is no information that is 'excluded information' within the meaning of sections 708A(7) and 708A(8) of the Act that is required to be set out in this notice.
