Rights Issue Results and Revised Timetable

Koonenberry Gold Limited (ASX:KNB) ("Koonenberry" or the "Company") is pleased to announce that the non-renounceable rights issue announced on 4 March 2024 ('Rights Issue') has closed.

The Rights Issue is fully underwritten by BW Equities Pty Ltd and Baker Young Limited ('Joint Underwriters). The shortfall shares (and free attaching options) will be issued to the Joint Underwriters and sub-underwriters in accordance with the allocation policy and underwriting and sub-underwriting arrangements summarised in the Rights Issue Prospectus.

In addition and as announced on 4 March 2024, the Company has received firm subscriptions to raise \$700,000 (before costs), via a placement to professional and sophisticated investors. The Placement will be completed in two tranches, with:

- Tranche 1 of the Placement Shares issued under the Company's existing placement capacity under ASX Listing Rule 7.1 on 12 March 2024; and
- Tranche 1 of the Placement Options, together with Tranche 2 of the Placement Shares and Placement Options to be issued, subject to shareholder approval at the Company's upcoming General Meeting on Monday, 22 April 2024.

The Rights Issue securities, including the shortfall securities, as well as the Placement securities outlined above will be issued on 26 April 2024 and the expected date for quotation of shares will be 29 April 2024.





To note that these dates are a revision to the timetable for the issue and settlement of Rights Issue shares as previously announced to the ASX on 8 March 2024. A revised timetable is following.

Following completion of the Rights Issue and Placement, the total amount raised will be approximately \$2.35 million (before costs) enabling the Company to accelerate the exploration and drilling activities at its Atlantis Cu-Au Prospect and Bellagio Au Prospect.
