Answer: No in the next quarter, the Company expects to have a significantly lower level of net operating cashflow. During the March quarter, lump sum exclusivity fees and due diligence costs related to a proposed acquisition was paid and/or undertaken which increased net operating cashflow. In any case, the Company will continue to review ongoing activities and has the ability to adjust expenditure according to available funding, if necessary.

Answer: On 23 January 2024, the company requested and was granted voluntary suspension pursuant to ASX listing rule 17.2. The voluntary suspension was requested pending the Company releasing an announcement in relation to a proposed re-compliance transaction under Listing Rule 11.1. Part of the proposed transaction will be a capital raise to which a prospectus is currently being prepared.
