HIGHLIGHTS

- **Soil sampling programme update on E63/1855**

Audalia Resources Limited (ASX: **ACP**) is pleased to present its report for the March 2024 quarter.

MEDCALF PROJECT

The Medcalf Project is a vanadium-titanium-iron project located some 470 kilometres south east of Perth near Lake Johnston, Western Australia. The Medcalf Project comprises of one granted exploration licence E63/1855, two miscellaneous licences L63/75 and L63/94 and two General Purpose licences G63/10 and G63/12 as well as mining lease M63/656. Together these licences cover a total area of 38 km².

The Medcalf Project lies in the southern end of the Archaean Lake Johnston greenstone belt. This greenstone belt is a narrow, north-northwest trending belt approximately 110 km in length. It is located near the south margin of the Yilgarn Craton, midway between the southern ends of the Norseman-Wiluna and the Forrestania-Southern Cross greenstone belts.

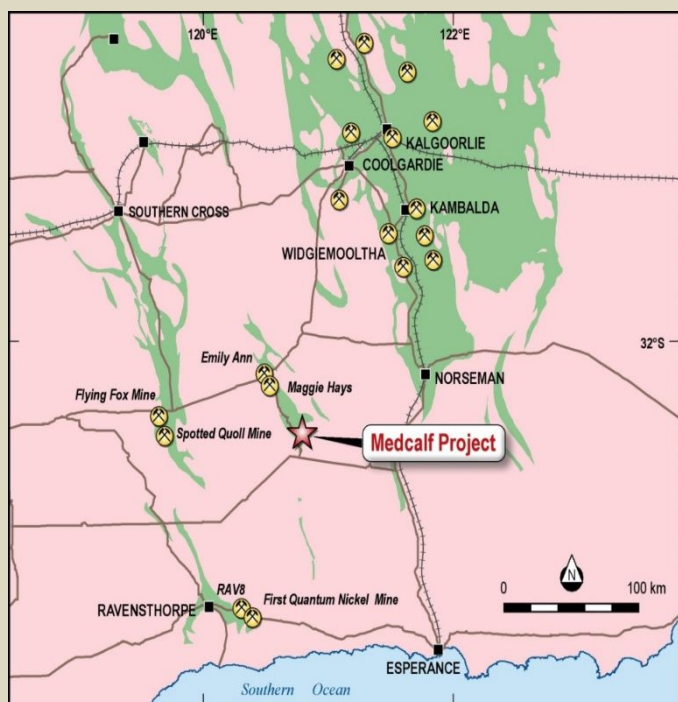


Figure 1: Medcalf Project - Location Map

Project Update

During the quarter, the Company continued to engage with the Environmental Protection Agency (WA) regarding the Medcalf Project. Completion of the primary approval process remains the immediate priority of the Company.

Exploration Update

During the December quarter, a soil sampling programme was completed on E63/1855, east of mining lease M63/656. The variable types of granites in the region give rise to the potential for lithium bearing pegmatites to be present.

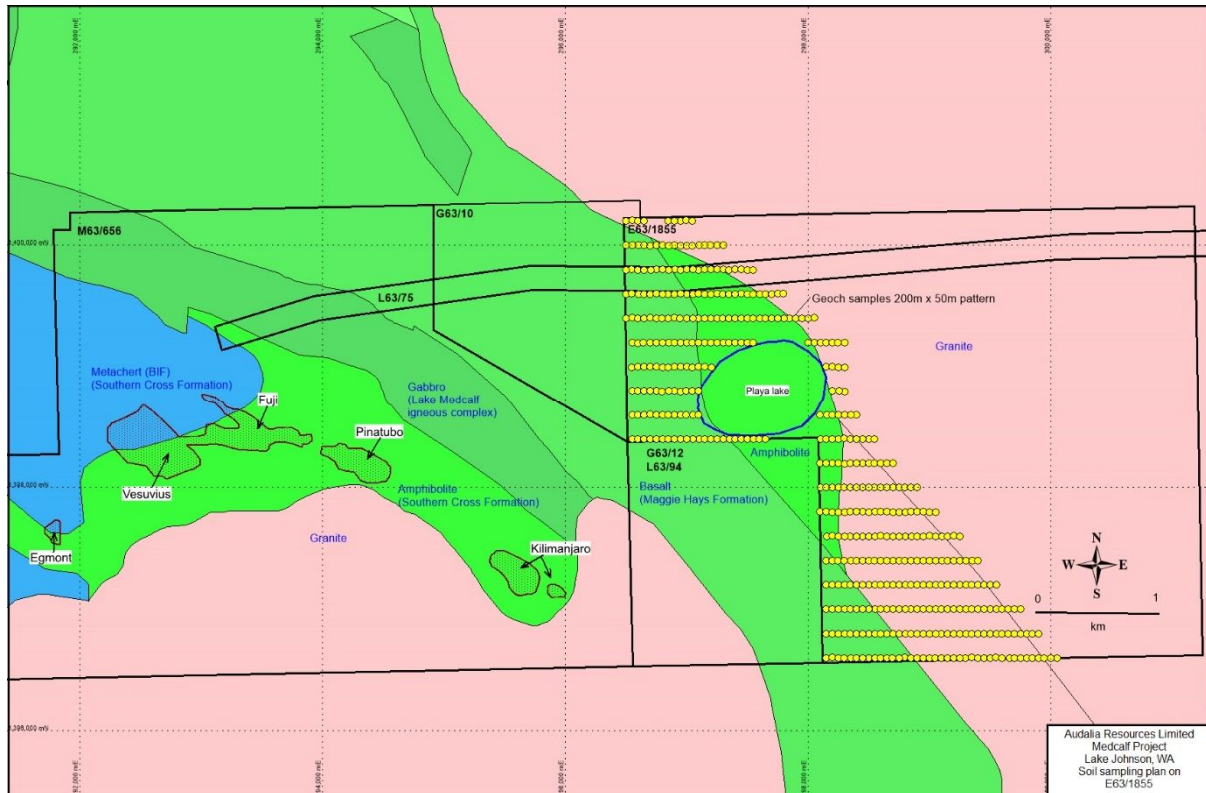


Figure 1 – E63/1855 soil sampling programme.

The programme sampled on 200m by 50m spacings over interpreted structures (Figure 1). A total of 484 samples were collected including 14 duplicate samples and 14 standard samples. A portable X-ray fluorescence (pXRF) was used for the analyses.

The raw data from the pXRF did not identify any pathfinder elements that would be considered anomalous. The playa lake sediments appear to have contributed to mask any identifiable anomalies. As the data included limited to no material information, Audalia did not proceed with calibration of the raw data.

Audalia is considering further analysis of the soil samples as well as alternative reconnaissance programmes.

Environmental status

The Project is currently compliant with environmental, legal and permitting requirements.

CORPORATE MATTERS

The Company had cash and cash equivalents as at 31 March 2024 of \$90,000 (Q2: \$11,000) following payments for capitalised exploration and evaluation expenditure of \$44,000 (Q2: \$207,000) and payments to related parties and their associates of \$20,000 (Q2: \$34,000) during the March 2024 quarter.

A A\$2million loan attract an 8% interest rate per annum (compounded daily) and the drawn down amount is payable in full (with accrued interest) on 31 January 2024. The amount is unsecured. On 14 September 2023, the Company announced that it has negotiated the extension of the repayment date to 31 July 2025.

A A\$1million loan attracts an 10% interest rate per annum (compounded daily) and the amount is payable in full (with accrued interest) on 31 January 2024. The loan is unsecured. On 14 September 2023, the Company announced that it has negotiated the extension of the repayment date to 31 July 2025.

As at 31 March 2024, the Company has access to a total loan facility of A\$3.0million from a director, Siew Swan Ong. Following are the details of each loan facility:

(a) On 16 June 2020, the Company has negotiated access to a loan facility of up to A\$1million to meet its working capital requirements (**Related Party Loan Facility**). The Related Party Loan Facility is unsecured, provided on interest free and fee-free terms and has an initial repayment date of 30 June 2022, which may be extended on the same terms by mutual agreement. On 30 June 2021, the Company announced that it has negotiated the extension of the repayment date to 31 January 2023. On 26 October 2022, the Company announced that it has negotiated the extension of the repayment date from 31 January 2023 to 31 January 2024. On 14 September 2023, the Company announced the extension of the repayment term from 31 January 2024 to 31 July 2025. Full details of the Related Party Loan Facility are set out in the ASX release dated 16 June 2020.

(b) On 29 October 2021, the Company has access to an additional loan facility of up to A\$1million with 5% interest rate per annum (compounded daily) to meet its working capital requirements (**Additional Related Party Loan Facility**). The Additional Related Party Loan Facility is unsecured, and the amount is payable in full (with accrued interest) on 31 January 2023. On 26 October 2022, the Company announced that it has negotiated the extension of the repayment date from 31 January 2023 to 31 January 2024. On 14 September 2023, the Company announced the extension of the repayment term from 31 January 2024 to 31 July 2025. Full details of the Additional Related Party Loan Facility are set out in the ASX release dated 29 October 2021.

(c) On 26 October 2022, the Company has access to a further additional loan facility of up to A\$500,000 with 5% interest rate per annum (compounded daily) to meet its working capital requirements. The loan facility is unsecured, and the amount is payable in full (with accrued interest) on 31 January 2024. On 14 September 2023, the Company announced the extension of the repayment term from 31 January 2024 to 31 July 2025. Full details of the loan facility are set out in the ASX release dated 26 October 2022.

(d) On 14 September 2023, the Company has access to a further additional loan facility of up to A\$500,000 with 5% interest rate per annum (compounded daily) to meet its working capital requirements. The loan facility is unsecured, and the amount is payable in full (with accrued interest) on 31 July 2025. Full details of the loan facility are set out in the ASX release dated 14 September 2023.
