The Board of Directors of 333D Ltd (ASX:T3D or “**Company**”) releases its cash flow report (**Appendix 4C**) for the quarter ending 31 March 2024 (“**the quarter**”) and provides an update on activities during the quarter.

QUARTERLY ACTIVITIES REPORT

Principal Activities

Using 3D printing technology, photogrammetry 3D scanning and a growing library of digital assets, the Company provides 3D-printing and design services on a bureau basis to organisations in Australia and around the world. The Company earns consulting and licencing fees for the integration and management of 3D printing and 3D modelling features into customer workflows that enable 3D print-on-demand and 3D view-on-demand of a variety of source file formats including DICOM and NFT.

Key areas of activity during the quarter

The Company continued to receive orders from its online retail and third-party wholesale sales channels for its products and services throughout the quarter and generated \$56,996 in cash receipts from customers and \$79 in interest income.

The Company reported positive net cash from operating activities of \$5,379 for the quarter.

Summary of expenditure incurred

Expenditure during the quarter was approximately \$51,696. The expenditure incurred and reported in the Appendix 4C during the quarter comprised;

The lenders are Conidico Superannuation Pty Ltd (up to \$100,000) and Saki Partners (Services) Pty Ltd (up to \$50,000).
