# QUARTERLY ACTIVITIES REPORT

**QUARTER ENDED 31 March 2024** 

Horseshoe Metals Limited (ASX: HOR) (Horseshoe, HOR or the Company) is pleased to present its Quarterly Activities Report for the period ending 31 March 2024.

#### **HIGHLIGHTS**

- Horseshoe pursuing <u>significant early cash flow opportunity from DSO</u> sales of existing high-grade copper stockpiles
- Discussions advancing with potential copper concentrate offtake partners – expected to be finalised this quarter
- Non-dilutive offtake funding under review
- Site activities expected to commence in early May
- Copper Surface Material resource assessment underway
- Review being undertaken of oxide and sulphide copper targets within 200km radius of Horseshoe Lights
- Horseshoe Lights Copper-Gold Project existing resource base includes:
  - Current in situ resource 128,000 t Cu metal @ 1.0% (0.5% cutoff)
  - Current M15 stockpile resource 2650 t Cu metal @ 1.1%
  - Current Flotation tailings resource 6,800 t Cu metal @ 0.48% and 15,300oz Au at 0.34 g/t
- Horseshoe continues to assess new project opportunities in WA considered complementary to the company's existing copper development strategy at Horseshoe Lights

Commenting on Horseshoe's copper strategy, Director Kate Stoney said: "In light of improving copper market conditions and increased investor interest in our Horseshoe Lights Copper Project in WA, we are pleased to report that our team is well advanced with plans to re-start field activities in the near-term.

Importantly, the Company is very well positioned to generate near-term cash flow via DSO sales of existing high-grade copper stockpiles. To this end, we can report offtake discussions are progressing well and are expected to be finalised shortly. This will provide Horseshoe with the requisite funding to accelerate exploration and development work that we believe will add considerable value for shareholders.

We have an exciting pipeline of work planned for the next 6-12 months and we look forward to updating the market on our copper strategy at regular intervals."

# Horseshoe Lights Copper-Gold Project, Western Australia

#### **Project Summary**

The Horseshoe Lights Copper-Gold Project is the original Cu/Au VMS discovery in the Bryah Basin and is located approx. 60 km west of DeGrussa Copper Mine owned by Sandfire Resources (ASX: SFR).

Past production from Horseshoe Lights includes around 316,000 oz Au & 55 kt Cu metal in two phases of mining and the deposit contains a current in situ resource 128 kt Cu metal @ 1.0% (0.5% cut-off) and 36,000 oz Au (refer Table 1).




Figure 1: Location of Horseshoe Lights and Kumarina Projects, WA

#### March Quarter Activity Update: DSO copper strategy to be accelerated

During the March quarter, Horseshoe completed detailed planning and review work to support near-term development activities at the Horseshoe Lights ('HSL') copper-gold system in WA.

A summary of the key activities planned for Q2 and Q3 2024 is outlined below.

#### **Copper Surface Materials Discussion**

#### Offtake Discussions Advancing

Discussions are ongoing with parties that have expressed interest in offtake of the DSO and potential future concentrates, including copper cement, produced at HSL. In addition, non-dilutive staged offtake funding is being considered to provide capital for the proposed development sequence.

#### <u>DSO – Scavenging Coarse Material</u>

Significantly the copper phase of mining included early DSO copper production that has left subgrade and rehandle DSO material around the site. Areas identified and assessed as having future DSO potential include, M15, Subgrade and C20 stockpiles along with rehandle and surface pimple dumps located on the North Waste dump, Gold tailings and Southern low-grade stockpile (Figure 1 – see release dated 31 October 2023). The coarse material is easily scavenged utilising loaders and excavators equipped with sieve buckets.

Site activities are expected to commence early May after a significant rainfall event during April.

#### **DSO Heavy Media Separation**

The amenability of the fines (- 100mm) material remaining in stockpiles and pimple dumps to Heavy Media Separation (HMS) is being investigated. Samples will be taken for HMS metallurgical testing during May to determine if a high-grade concentrate can be produced utilising this relatively simple off the shelf technique.

#### Pilot/Small Scale Oxide Heap/Vat Leach and Cementation

Previous test work has indicated that the oxide material at HSL is amenable to acid leaching followed by either cementation of SXEW copper recovery. Significant tonnages of material exist in stockpiles (e.g. M15 – Figure 1 and Table 1) that will be further tested and assessed to determine the viability of a pilot /small scale operation to recover copper cement as a first step to assist in the feasibility study for oxide copper production at a larger scale.

#### <u>Large Scale Oxide Heap/Vat Leach and Cementation</u>

Assessment is underway to determine if the existing information available is sufficient to complete a resource calculation of surface resources outside of existing resources at M15 and the Sulphide tailings. In addition, a review of potential copper targets within 200km of HSL is being undertaken. Discussions are underway with a management group experienced in copper oxide vat/heap leach cementation operations to supervise the development at HSL.

#### **HSL Copper Strategy: Next steps**

The following activities are planned to further investigate the surface materials:

- Additional RC and/or auger drilling of the North Dump, gold stockpiles, copper Lowgrade oxide and Low-grade sulphide stockpile stockpiles
- Auger drilling of the gold and copper rehandle areas
- Acid leaching test work on oxide copper stockpiles and targets
- Gravity recovery test work on Copper Flotation and CIP tailings
- Detailed assessment of the recovery of high-grade chalcocite, digenite and covellite DSO remnant from the historic mining phases via mechanical scavenging and/or heavy media separation.

Updates on the above activities will be provided as they progress in the coming weeks.

## Horseshoe West, Western Australia

(HOR: 100%)

The Horseshoe West tenements are located approximately 1.5 km west of the Company's existing Horseshoe Lights copper-gold deposit and are considered prospective for Horseshoe Lights style Volcanogenic Massive Sulphide (VMS) copper-gold and shear-zone hosted gold mineralisation.

Evaluation of existing geologic mapping and geophysics data sets has commenced with a view to determining priority copper and gold targets. Ground reconnaissance of identified targets will commence during the June quarter.

No active field work was undertaken during the March quarter.

# Kumarina Copper Project, Western Australia (HOR: 100%)

The Kumarina Project consists of a mining lease and mining lease application covering approximately 3.2 km². The Project is located 95 km north of Sandfire Resources NL's DeGrussa copper-gold mine in the Gascoyne region of Western Australia. The Company has applied for a mining lease (MLA52/1078) to cover the Rinaldi resource, contiguous with M52/27. The Company continues to progress a Project Agreement as part of the application process with the Native Title Party and its lawyers.

No active field work was undertaken during the March quarter.

#### South Australia

# Glenloth Gold Project, South Australia (EL6301 and rights to explore and develop ML5848, ML5849, ML5885 & MPL62)

The Glenloth Project is located in the Central Gawler Craton of South Australia. The project consists of a single exploration licence, EL 6301, which comprises two areas totalling 107 km². The larger eastern block *Glenloth* covers 81 km² and includes the Glenloth Goldfield and part of the Harris Greenstone Belt. The smaller western block *Old Well* takes in the northern trend of the 1.0M oz Tunkillia gold deposit located 6 km to the south, under development by Barton Gold Holdings Ltd (ASX:BGD). The Company also holds the rights to explore and develop ML 5848, ML 5849, ML 5885 and MPL 62 within the eastern block of EL 6301.

At Glenloth gold occurrences typically consist of relatively thin (ca. 1 m width), high-grade mineralised quartz veins, hosted by sheared and fractured Archaean to Paleoproterozoic Glenloth Granite, and contacts with dolerite dykes. A shallow Hiltaba Suite batholith has been proposed as the source of mineralisation. Six kilometres south of Old Well, the Tunkillia deposits (Areas 223, 191, 51) are characterised by a large hydrothermal system associated with the Yarlbrinda Shear Zone, which passes into the Old Well tenure.

Evaluation of available geochemical, geophysics and historic drilling data along strike to the north from the Tunkillia deposits was completed over the "Old Well" section of the project area to determine the appropriate future field programs.

No active field work was undertaken during the March quarter.

#### Corporate

#### **Short-term loan**

In March 2024, the Company entered into a short-term loan agreement with Obsidian Metals Group Pty Ltd ("Obsidian") to meet short-term capital requirements. As at 31 March 2024, funds of \$56,000 have been advanced by Obsidian under the agreement. The Company's non-executive director Ms Kate Stoney is a director of Obsidian. For the avoidance of doubt, Ms Stoney holds no personal interest in any financial or other benefit arising to Obsidian from the loan agreement.

#### Listing Rule 4.10 disclosures

Additional disclosures required by ASX Listing Rules 4.10.5, 4.10.7 and 4.10.16 are included below in Appendix 2. These disclosures were required to be included in the Company's annual report released on 28 March 2024, but were omitted due to an oversight.

The amount of payments to related parties and their associates disclosed in section 6.1 of Appendix 5B accompanying this report was \$2,000. This consisted solely of payments of non-executive director's fees. Other payments to related parties and their associates have been deferred to later quarters as the Company seeks to preserve capital.

#### **About Horseshoe Metals Limited**

Horseshoe Metals Limited (ASX:HOR) is a copper and gold-focused company with a package of tenements covering approximately 500 km² in the highly prospective Peak Hill Mineral Field, located north of Meekatharra in Western Australian and mineral interests in South Australia. The Company manages the Horseshoe Lights Project and the Kumarina Project in Western Australia, and the Glenloth Gold Project in South Australia.

#### About the Horseshoe Lights Project

The Horseshoe Lights Project includes the historic open pit of the Horseshoe Lights copper-gold mine which operated up until 1994, producing over 300,000 ounces of gold and 54,000 tonnes of contained copper including over 110,000 tonnes of Direct Shipping Ore (DSO) which graded between 20-30% copper.

The Horseshoe Lights ore body is interpreted as a deformed Volcanogenic Hosted Massive Sulphide (VMS) deposit that has undergone supergene alteration to generate the gold-enriched and copper-depleted cap that was the target of initial mining. The deposit is hosted by quartz-sericite and quartz-chlorite schists of the Lower Proterozoic Narracoota Formation.

Past mining was focused on the Main Zone, a series of lensoid ore zones, which passed with depth from a gold-rich oxide zone through zones of high-grade chalcocite mineralisation into massive pyrite-chalcopyrite. To the west and east of the Main Zone, copper mineralisation in the Northwest Stringer Zone and Motters Zone consists of veins and disseminations of chalcopyrite and pyrite and their upper oxide copper extensions. The table below summarises the total Mineral Resources for the Horseshoe Lights Project at the reporting date.

#### About the Kumarina Project

The copper deposits at the Kumarina Project were discovered in 1913 and worked intermittently until 1973. The workings extend over nearly 5km as a series of pits, shafts and shallow open cuts. At the main Kumarina Copper Mine, the workings are entirely underground with drives from the main shaft extending for some 200 m in the upper levels and for about 100 m in the lower levels at a depth of 49m below surface.

Incomplete records post-1960s make it difficult to estimate the total copper production from the workings. However, indications are that the Kumarina Copper Mine was the second largest producer in the Bangemall Basin group of copper mines. Recorded production to the late 1960s is 481 t of copper ore at a high-grade of 37.0% Cu and 2,340 t at a grade of 17.51% Cu. An initial Mineral Resource Estimate for the Rinaldi deposit was completed by the Company in 2013 (see 30 June 2013 Quarterly Report announced on 31 July 2013). The total Measured, Indicated and Inferred Mineral Resource Estimate at the reporting date is shown in the table below.
